#### **Terms & Conditions**

### 1. Appointments & Bookings

All appointments must be booked in advance, either online at www.sportsrehab.uk, by phone, or in person at our clinic. Appointment times are subject to availability and confirmation. We reserve the right to refuse or cancel bookings at our discretion.

#### 2. Cancellations & No-Shows

A minimum of 24 hours' notice is required for cancellations or rescheduling. Cancellations made less than 24 hours in advance may incur a cancellation fee of up to 100% of the session cost. Clients who fail to attend without notice ('no-shows') may be required to pre-pay for future appointments.

### 3. Payment Terms

Payment is due at the time of the appointment unless prior arrangements have been made. We accept major credit/debit cards, contactless payments, and bank transfers. If using health insurance or a third-party provider, please confirm coverage in advance. Clients are responsible for any fees not covered by their insurer.

#### 4. Refunds

We do not offer refunds for completed services. Refunds for prepaid sessions or treatment packages will be considered on a case-by-case basis and may incur a £10 administration fee. Sessions in a package are non-transferable and must be used within the validity period specified at purchase. \*\*All package sessions must be booked and used within an 8-week period from the date of the first appointment.\*\*
