- □ Name, Address, Phone, Email for taxpayer and spouse
- □ Date of Birth and Social Security Number for taxpayer, spouse and dependents
- □ Copy of Driver License or Picture ID for taxpayer and spouse
- Copy of Prior Year Tax Return (if available)
- □ IRS IPPIN Notice CP01A tax returns filed with a PIN #
- □ IRS Notices (e.g., amendment, proposed changes, offsets)
- Bank Routing & Account Number (tax refunds direct deposited)

INCOME

- □ W-2 (wages, salaries, tips)
- □ K-1 Income Partnerships, S-Corp, C-Corp, Non-Profit, Trust
- □ Real Estate, Rental, Alimony, Farming, Jury Duty, Scholarships
- Gig Economy (cash, goods, bitcoin, rideshare, delivery, online store)
- □ 1099-NEC non-employee compensation (at least \$600)
- □ 1099-MISC rents, royalties, prizes, gambling, awards
- □ 1099-K payment card, third party networks (e.g., PayPal, Cash App, Square)
- □ 1099-G government, unemployment, offsets
- □ 1099-C cancellation of debt
- □ 1099-B capital gains
- □ 1099-R retirement income, IRA, 401K, pension and annuities
- □ 1099-INT interest income
- □ 10999-DIV ordinary dividends

ADJUSTMENTS AND CREDITS

- Earned Income Credit EIC and Child Tax Credit CTC
- □ Child and Dependent care (need center name, address, phone, EIN)
- □ First-time homebuyer, residential energy, alternative fuel, moving expenses, etc.
- □ Adoption credit, alimony paid, savers credit IRA, health savings, etc.

ITEMIZED DEDUCTIONS AND CREDITS

□ Medical and dental expenses

- □ State, local sales tax, mortgage interest, points, insurance premiums
- Gifts, donations to charity, investment interest, casualty and theft losses
- □ Gambling losses, unrecovered investments, disabled work expenses

INCOME

- □ Income Types: Self-Employed, Freelance, Independent Contractor, Gig-Work
- □ Cash, check, gross receipts, sales revenue, COGS, other income
- □ Cash received through Pay Pal, Cash App, Zelle, Square, Apple Pay

EXPENSES

- Employee wages, commission, profit sharing, contractors
- □ Office supplies, phone, internet, training, seminars, professional fees
- □ Uniforms, permits, charity donations, employee benefits, insurance
- □ Rent, lease, repairs, utilities, rental insurance, maintenance
- □ Homeowners insurance, mortgage payments and interest
- □ Travel and entertainment, meals, gifts, tips, other
- □ Auto and truck repairs, maintenance, fuel, mileage, premiums
- □ Auto tax, tag & title, insurance, tolls, parking
- □ Tax prep fee, association dues, safe deposit box
