The consignment term is 30 days, expiring on _____. A **\$40** fee may be charged against the Seller if he/she cancels consignment and/or removes firearm prior to the end of the term. If, at the end of the consignment term the firearm is not sold and no other agreements are made, the Dealer returns the firearm and any accessories to Seller after doing the "4473". After years of expertise, we've determined that starting GunBroker auctions at \$0.01 maximizes your sale's potential. While there are no guarantees on the final sale price with this approach, we will leverage our skills to market your item to the most qualified buyers. If you opt for a GunBroker reserve, an additional 3% commission will be applied, bringing the total to 18% (on top of the standard 15%) if the item sells. Dealer: (a) agrees to make best possible effort to sell the firearm during the term, (b) agrees to supervise careful handling, display, and storage of the firearm, (c) agrees not to remove firearm from premises, such as for test firing, etc., without prior permission from the Seller, (d) agrees that the sale and/or transfer be totally legal by obeying all applicable Federal, State, and/or local laws, including adhering to the above consignment terms, and (e) agrees to pay Seller the sale price, minus sales tax, and the dealer fee or %, when the firearm is sold and monies collected.
