

Rules Governing Vehicle Parking on Streets, Driveways and Garages:

In accordance with Article 5, Sections 5.1 and 5.2 of the <u>Bylaws of the Villas at Flintrock Condominium Association, Inc.</u>, the Association may adopt rules and regulations for the maintenance, management, operation, use, conservation, and beautification of the Condominium Regime. The following rules were adopted by the Association's Board on the date set forth below and become effective thirty (30) days after being mailed to the membership.

 Vehicle Parking: The parking restrictions set forth in paragraph 13 of the <u>SUPPLEMENTAL DECLARATION TO FLINTROCK AT HURST CREEK</u> <u>MASTER DECLARATION OF COVENANTS, CONDITONS AND</u> <u>RESTRICTIONS</u> are hereby reiterated and incorporated in these adapted rules:

"Parking of vehicles overnight on the street is not permitted. All recreation vehicles, campers, boats, trailers, etc. must be stored in garages. No unregistered or inoperable motor vehicle or trailer of any kind may be disassembled, serviced, repaired or stored on the land except in an enclosed building."

The restrictions set forth in Article 5, Sections 5.13 & 5.14 of the <u>Declaration of Condominium Regime for Villas at Flintrock, Inc.</u> are also reiterated and incorporated in these adapted rules.

- Garage Parking: The primary purpose of garages is to house two vehicles.
 Overnight parking on driveways should be avoided when garage parking is available.
- 3. <u>Driveway Parking:</u> Overnight parking for more than one vehicle on driveways is restricted to a maximum of three nights.
