## CONTRACT FOR COMPETITIVE SPORT CHEER (CSC - STUNT) OFFICIALS

- 1. Officials fees will be paid by the following:
  - (1) NCSOA to invoice Host Program/School
  - (2) Host Program/School send check directly to NCSOA
  - (3) NCSOA to pay Officials

Official fees are as follows:

- Regular Season \$50 per official per game (assigning fee not included in this amount)
- Post Season rate determined by league/section
- Tournaments (5 or more games same date) –\$50 per official per game/determined by section for post season Certified officials provided by NCSOA will render officiating services for the games scheduled for the **2026** season in with three (3) officials for regular season (league and non-league) games and four (4) officials for selected post season games upon availability. NCSOA will contact the league contact if the adequate number of officials are unavailable; two (2) scoring officials are allowed. League/host school will pay officials the amount stated above for services provided.
  - The obligation of the school ceases if the game is cancelled prior to 48 hours of game time because of circumstances deemed acceptable by the NCSOA. All officials and assigning fees are still due in case of forfeit or no show of any team.
- 2. Assigning fees are \$200 per season applicable to all program/schools participating in CSC STUNT. Assigning Fees to be paid to NCSOA. These fees are separate from Officials Fees.
  - All program/schools participating in CSC STUNT are responsible for the assigning fee per season.
- 3. NCSOA will provide officials located within a fifty (50) mile radius. If any officials are not available within the allotted area, NCSOA will notify program/school and games may need to be rescheduled or cancelled at no cost to the program/school.
- **4.** The initial season schedule shall be submitted to NCSOA by the League/program representative by November 15<sup>th</sup>. Any schedule changes after January 15<sup>th</sup> will incur a \$20 charge per change and will be the responsibility of the host program/school. Schedule change is defined as a date, time, or location change.
- **5.** If there is a change in Athletic Directors of the program/school the NCSOA shall be notified within two weekS of the change for billing purposes.
- **6.** If the program/school fails to fulfill the obligation of any part of the contract, the remainder of the contract shall not be binding, and officials will not be provided by NCSOA for any future games, contests, and activities until obligations have been met.
- **7.** Services provided by the officials are as an independent contractor and not an employee of CASOA, or the school, or organization. This contract is valid for the full season listed above and photocopies will be treated as originals.
