North Coast Native Protectors (NCNP), a Nativemanaged non-profit was founded in 2019 with a mission to promote clean water, healthy oceans, and Tribal management. The NCNP established a statewide Tribal Marine Collaborative (TMC), which serves as a platform for Tribes, indigenous people across California and allies across Turtle Island; to come together to share challenges and successes, network, and find solutions towards a sustainable future for all. `

The MPA Collaborative Network, California Department of Fish and Wildlife, and the California Fish and Game Commission hosted events on March 14th-16th in Monterey, CA to discuss the management of California's 124 marine protected areas.

California MPAs comprise the largest ecologically-connected network of its kind in the world, which includes estuaries, intertidal zones, rocky reefs, kelp forests, soft marine bottoms and submarine canyons. The California Marine Protected Area (MPA) Collaborative Network was established 2012 to empower diverse communities to engage in marine protected area stewardship for a healthy ocean. The network includes 124 MPAs and 14 MPA Collaboratives throughout the coastline of California, all of which fall within the boundaries of federal, state and locally recognized California indigenous tribes.

TMC is building relationships throughout the state with tribal leaders, MPA Collaborative Network, Fish & Game Comission, UC and CSU School systems and local community members to create an engaged and holistic future for marine management in California. There is an increasing awareness of the need to collaborate with Indigenous peoples and support Indigenous leadership; as a vital key to healthy and sustainable coastal/marine management. TMC's first step was to pay respect and recognize their role as a guests within the traditional lands of the Esselen Nation (Ohlone Costanoan), now known as Monterey, and was welcomed by Chairwoman Louise Ramirez.

TMC is currently gearing up for the Tribal Water Summit in Sacramento on April 11-13, participation in this summit will help inform policy makers for California water policy and advance issues of equity, access and incorporation of Traditional Ecological Knowledge in the California State Water Plan (water.ca.gov). 

Tribal Nations, Federal, State and Local agencies come together to create pathways towards sustainable water management and preserving Tribal Water Rights in California

The Tribal Marine Collaborative attended the fourth Tribal Water Summit in Sacramento on April 11 – 13 2023, hosted by the The Department of Water Resources (DWR). Tribal representatives throughout the state, along with federal, state, and local agencies came to gather and discuss California water issues, on-going preservation of tribal water rights and creating sustainable management of California's sacred waters

The DWR's role is to manage California's water resources, systems, and infrastructure, including the State Water Project (SWP), in a responsible and sustainable way. The DWR has committed to a Tribal Policy which states that; open, inclusive and regular communication with tribal governments and communities. The Tribal Policy Advisor, Anecita Agustinez is the central point of coordinated communication and consultation with California Native American tribes to ensure proactive and meaningful consultation.

TMC outreached for the Tribal Water Summit, and was able to gain more participation from Tribal Leaders and Cultural Bearers throughout the state. In attendance was Chairwoman Louise Ramirez of the Esselen Nation and Chairwoman Quirina Geary of the Tamien Nation; both which are near the Sacramento-San Joaquin Delta project which provides the water supply to 27 Million residents and Agricultural Industry. The many uniquely affected Indigenous nations and communities, can tell generations long perspectives of water mismanagement and diversions. This knowledge and perspective can inform California State policies to support Tribal Leadership, protect Tribal water rights and including TEK(Traditional Ecological Knowledge) practices throughout the state.

## AB 1284 Tribal ancestral lands and waters: cogovernance and comanagement agreements Author: Member Ramos

Text from the Bill itself, as is only mentions Federally recognized tribes in regards to cogovernace and comanagement of natural resources.

AB 1284 as amended by Ramos. Tribal ancestral lands and waters. Waters: cogovernance and comanagement agreements. Existing law governs various interactions between the state and federally recognized Native American tribes within the state. Existing law encourages and authorizes all state agencies, as defined, to cooperate with federally recognized California Indian tribes on matters of economic development and improvement for the tribes
