UPDATE: Pleasure House Point (PHP) Project Approved

City Council approved the Pleasure House Point (PHP) project, which will transform the acreage to a wetland.

As shared in a previous newsletter, the short amount of time between the Bay Advisory Commission's presentation in late November and City Council vote in January, as well as the planned tree removal and wildlife disturbance, led to many citizens objecting to the project. With no other wetland credits available in our HUC (hydrology unit code) to use, Council felt this project would provide the necessary credits to offset stormwater mitigation projects. including those within the PAPCL area, and restore the PHP property to a wetland status.

Local environmental groups worked with the City to establish dates and times to salvage live oak and other tree saplings and seedlings from the PHP project zone. Volunteers are needed to locate, dig and pot native trees and shrubs. Those interested can check the following link for details and sign up. The dates are February 4 & 5, and February 7 & 8, with two work slots for each day. There is a maximum 30 volunteers for each slot.

General Assembly Bill Renaming I-264 Bridge Closer to Passing

A bill that would name a bridge after Virginia Beach firefighter Matthew "Chevy" Chiaverotti advanced through the Virginia General Assembly in late January.

Chiaverotti served for over 20 years in the Virginia Beach Fire Department, rising through the ranks to become the captain of Engine 7. He also served as a FEMA search team manager with Virginia Task Force 2. In 2012, he spent hours at the scene of the F/A-18 Hornet jet crash known as the Good Friday Miracle. Chevy was diagnosed with an occupational cancer in August 2022, and at 44 years of age he passed away in April 2023.

With passage of the bill, the bridge on I-264 over S. Rosemont Road would be renamed "Capt. Matthew "Chevy" Chiaverotti Memorial Bridge."

January 2025 League Minutes

Officers and committee chairs gave their respective reports. While the League is working on speakers for future meetings, member suggestions and topics are always welcomed. Flood Committee Chair Bob Jennings advised there will be an insurance agent update to the risk rating for flood insurance. He suggested homeowners with a crawl space consider flood vent to help mitigate water damage in the event there is flooding, and for homes with a gas supply be inspected before returning to the home if the gas had to be turned off. He also suggested extra batteries handy for vehicles using a fob to enter and start the vehicle.

Public Works Engineer Mike Mundy provided stormwater mitigation updates and operational statistics such as: Old Forge/Red Lion punch list items are in progress and should be completed within a couple of months; there will be no truck traffic for a couple of months as crews are working on site cleanup (Phase 1 is projected to be completed by June 2026); S. Plaza/ Presidential work should be done by the end of the year; and shutting the tidal gates take about 20-30 minutes per gate. Mundy invited all to look at short "How It Works" You Tube videos the City created to inform citizens on various projects. Mundy also addressed how the Pleasure House Point project approval

will provide wetland credits to ensure current stormwater projects continue.

Windsor Woods Area Library manager Erica Cooper said adult and teen programs are in gear and she's looking for teen advisors. There's an adult reading challenge (12, 24 or 52 books), the Central Library needs an art gallery coordinator, and she shared work force council, food and other resources info sheets.

District 3 Councilman Michael Berlucchi gave an update about the Genesis dealer's request for a modification of conditions involving the land that was formerly known as Sentara Way Woods. He and the PAPCL president will meet with residents for their input on proffers and set up a meeting with Checker Flag/Evergreen LLC reps. He also said there was a remediation plan in place for the trees that were improperly removed from VDOT property.

A representative for Jason Miyares' 2025 Attorney General Campaign explained requirements for the Virginia Petition of Qualified Voters and that he was collecting signatures on behalf of Miyares'.

The Larry's won the evening's drawing and graciously donated their winnings back to the civic league.
