## Great Neck Estates Civic League Requesting Support

The Great Neck Estates Civic League is asking for the support of civic leagues in opposing a builder's "spot zoning" proposal which would rezone a portion of a neighborhood into a business district. You may be familiar with the Wycliffe Church decision to sell a portion of land it owns to a developer who planned to fill in existing wetlands to build homes. The latest request to be presented to City Council is a plan that essentially moves the property from church use to residential and business zones. Area residents were against both plans for various reasons. including a great concern that the development would create flooding in the existing neighborhood, as well as setting a precedent for other lakes, waterways and wetlands to be fair game for similar actions. ## Sentara Way Woods Razed

The League is saddened to report that the efforts of the League and residents were not successful in coming to an agreement with Winners, LLC, to save a meaningful portion of what is widely referred to as Sentara Way Woods. Three-plus acres of old growth trees were razed recently to make way for what is expected to be an office building with parking as opposed to

vehicle inventory storage, which requires a CUP (Conditional Use Permit). The League will continue to monitor the situation and be prepared to oppose a CUP.

In December 2021, the League and residents asked City Council to not approve a CUP by Winners, LLC for a new dealership building, auto repair and vehicle inventory storage plan because of past CUP violations and in hopes we could negotiate for either preservation of a greater amount of trees or the opportunity to rezone the property and obtain the land for preservation. After multiple meetings with the property owners and/or representatives, we were able to secure some victories, most notably is that the new dealership building will now be located closer to the self-service storage facility vs. directly across the street from Windsor Forest homes. In January 2023, underbrush on the property was cleared. We learned of the trees being removed in early March 2024. Although the woods are gone, an office building will offer some relief as it will operate during "normal" hours versus the noise, light and after hours heavy truck traffic created by a dealership.

Thanks to all the PAPCL, Inc., members, city-wide civic league members and residents who supported our efforts, as well as those on Council who listened to our concerns.
