PLEASE NOTE:

The utmost care will be given in watching both your pet(s) and your home, and all access codes will be safeguarded. If anyone else has access to your home during the pet-sitting service dates, Beachwalk Luxury Pet Concierge, LLC, can assume no liability for any damages or losses to your home or pet.

Due to the unpredictability of pets, we cannot accept responsibility for any mishaps outside of our control, while we are not present in the home. Nor can we be liable for injury, disappearance, or death of pet(s) with access to the outdoors, such as dog or cat doors, while we are not present.

Leash Walking Policy:

Only one or two dogs will be walked at a time for the safety of the dogs and walker. If your dog pulls heavily, we require a no-pull harness. Our safety practice is to not interact with other dogs or people when leash walking. We allow dogs to stop and sniff for enrichment while walking. Studies have shown that 20 minutes of sniffing is equivalent to an hour's walk in terms of enrichment and mental stimulation.

Unsafe Temperatures/Inclement Weather Policy:

We will walk your dog rain or shine if they are willing to go. In the months of extreme summer temperatures or severe weather, walks and time spent outside will be based on your pet's safety. To avoid heat exhaustion and foot pad injury, we opt to potty your dog in a grassy area and forfeit sidewalk walking in exchange for engaging indoor play, such as fetch, playing with enrichment toys and puzzles, and treat training.

TERMS & CONDITIONS

The parties agree as follows:

- 1. All bookings under \$200 require a \$25 deposit to hold requested service dates via cash, check or venmo. All bookings over \$200 require a \$50 deposit. This deposit will be applied to your upcoming services. Once deposit payment is received, your booking is confirmed. The balance of payment can be made via Check (made out to Cherie Weir), or Cash only, and is due at the first scheduled visit. Please leave payment on the counter.
- 2. Please give 2 weeks' notice for cancelling scheduled vacation pet care. This ensures that we have time to fill our schedule and give other clients the opportunity to schedule our services.
- 3. **Holiday Rates**: On Thanksgiving week, Pinellas County Winter Break, Pinellas County Spring Break, there is an additional \$5 fee per visit, and \$10 for overnights. On Martin Luther King Day, President's Day, Memorial Day, & Labor Day, there is an additional \$3 per visit and \$5 for overnights.
- 4. **For vacation visits**, there is a minimum of 2 daily visits for dogs in a 24-hour period for up to 4 days. After 4 days, we recommend 3 daily visits for wellbeing. If potty accidents happen, a 3rd visit will be added to the schedule. (4 visits/ tailored plans can be discussed for puppies under 1 year old) A minimum of 1 visit for cats and other pets in a 24-hour period is required.
- 5. **Additional pets over 2** will be charged at the rate of \$3 per dog, \$2 per cat, \$1 per bird or small animal per visit. Overnights \$5 per dog, \$2 per cat.
- Client may make text/phone reservations for additional service at any time during the term of this contract, subject to
 Pet Sitter availability. We appreciate as much advance notice as possible and will make every effort to accommodate
 all requests.
- 7. Both Pet Sitter and Client recognize that the welfare of the animal is the highest priority. In the event of emergency, Pet Sitter will make all reasonable attempts to contact the Client. If the Client cannot be reached, Pet Sitter is authorized to seek veterinary care in an emergency with release from all liabilities related to transportation, treatment, and any other expenses. The client agrees to reimburse Pet Sitter for all incurred expenses. All attempts will be made to use Client's Veterinarian listed above, or with an emergency veterinary care provider should Client's Veterinarian be unavailable.
- 8. Locksmith Clause: If Pet Sitter is required to employ a locksmith to enter Client's premises due to a malfunction of a lock, or a lockbox, it shall be the responsibility of the Client to reimburse for all costs incurred. The Client expressly gives Pet Sitter the authority to employ a locksmith on Client's behalf in the event of a lock out.
- 9. In the event of inclement weather, natural disaster or circumstances beyond our control, Pet Sitter is entrusted to use best judgment in caring for pet(s) and home. An emergency contact must be listed to take Client's pets in case of hurricane and/or evacuation. We cannot take Client's pets during an evacuation.
- 10. In the event of personal emergency or illness of Pet Sitter, Client authorizes Pet Sitter to arrange for another qualified person to fulfill responsibilities as set forth on this contract. Every attempt will be made to notify the Client regarding such situation. The key staying on the property where pets reside, in a lockbox is ideal in case of emergency of Pet Sitter, and shared care becomes necessary.
- 11. All pets are to be currently vaccinated for rabies. Under no circumstances can Pet Sitter start care for any pet that has a contagious illness. Client must disclose any health issue with Pet Sitter and on service contract.

12. We request that in our care, all dogs and cats wear an ID tag stating their name and your phone number for added security.

13. Aggressive Pet Policy:

Caring for potentially, or known to be, aggressive pets put our pet sitters at risk. Client is obligated to disclose any past or present temperament issues with pet(s). If Pet Sitter, in his/her sole discretion, feels that a pet is showing threatening behavior & danger exists to the health or safety of Pet and/or Pet Sitter, Beachwalk Luxury Pet Concierge, LLC, reserves the right to immediately terminate this contract for all party's safety, and contact Client. If Client cannot return home for continued care, then Client authorizes pet to be cared for by Emergency Contact, or placed in a kennel, with all charges therefrom to be charged to Client. Every attempt will be made to notify Client regarding such situation.

14. This contract will take effect upon signature by both Client and Pet Sitter and will remain in effect until terminated by either party as provided.
