

Fairfax County is projecting a significant budget deficit for FY 2011 (beginning July 1, 2010). The county's ongoing challenge is to develop a budget with services that are both sustainable and acceptable to the community.

Fairfax County Government and Fairfax County Public Schools invite you to register and attend one of 12 Community Dialogues being held this Fall to share your feedback on the impacts of recent budget reductions as well as seek solutions to close the FY 2011 budget gap. 

Education Committee Report

School Bond Referendum on Nov 3 Ballot

A school bond referendum will be on the general election ballot Tuesday, November 3, 2009. Polls will be open from 6 a.m. to 7 p.m. Residents of Fairfax County may vote if they are 18 years of age or older on Election Day and have registered to vote 29 days prior to the election (by October 5, 2009, at 5 p.m.).

The 2009 proposed bond referendum includes \$104.3 million for renovations, including \$101.8 million to renovate Marshall High School; \$2.5 million for renovation planning at Sandburg Middle School; \$65 million for new construction and modulars; and \$26.2 million for infrastructure management, including roof replacements, heating, ventilation, and air conditioning (HVAC) replacements, athletic improvements, security enhancements, asphalt paving, and improvements required by the Americans With Disabilities Act.

The 2009 bond referendum includes \$50 million for construction of the new middle school in the South County area of Fairfax County and \$40.7 million for capacity enhancements at Crestwood, Cunningham Park, Kings Park, Lynbrook, Spring Hill, Springfield Estates, West Springfield, and Woodley Hills Elementary Schools and Whitman Middle School.

Building and renovation of schools are not financed through the school system's operating funds, but through bonds.

Thomas Jefferson High School Applications

Applications will be available September 28 for Thomas Jefferson High School for Science and Technology. The deadline Is October 23.

Any eighth grade student who lives with a parent or legal guardian who resides full-time in a participating school division (the counties of Fairfax, Arlington, Fauquier, Loudoun, or Prince William or the city of Falls Church) AND who is enrolled in Algebra 1 or higher level mathematics in grade 8 is eligible to apply to Thomas Jefferson High School for Science and Technology (TJHSST). TJHSST offers a comprehensive college preparatory program emphasizing the sciences, mathematics, and technology. The school serves students who are selected on the basis of aptitude, prior academic achievement, and genuine interest and motivation in the biological, physical, mathematical, and computer sciences and who intend to pursue college preparation in the sciences, engineering, or related fields.

Applications will be available from a liaison counselor in all public middle schools and most private schools in the participating divisions beginning September 28. The application deadline is October 23. Submission of the application registers the student to take the admissions test on Saturday, December 5.

A student handbook for test preparation is available for download from the admissions web site at <u>www.TJAdmissions.org</u>. Students without computer access will be able to obtain copies of the handbook from middle schools in all school divisions that participate with TJHSST.

You must complete and submit the freshman application to TJHSST by October 23 in order to register for the test and to be considered for admission. For more information, refer to http://www.fcps.edu/news/tj.htm.

Membership Meetings

The Planning and Zoning Committee met on October 8, 2009. Several issues concerning our area were discussed. The owner of the IMP building, beside Roy Rogers on Route 1, is proposing to rezone the entire 8.82 acre parcel from R-2 and C-8 to C-8. Currently, only a small amount is R-2. He wants to leave the IMP office building and add two new hotels. One hotel would have 190 rooms and the second hotel would have 80 rooms.

The owner already has Fairfax county staff approval and the approval of the MVCCA transportation committee. However, the P and Z committee had not seen the plans or heard about them until last night. The committee expressed serious concerns about the need for two hotels and stated the community needs a conference center or special events facility at that location. The planning commissioner, Earl Flannigan, also strongly suggested the need for a conference center at that site. We did not vote on the application but suggested the developer rework his proposal and visit us again.

Some important tidbits about that application follow. I asked if the proposed buildings would be all brick and have some colonial design as it is in a historical overlay district. The Architectural Review Board (ARB) told the developer they did not want a colonial design for the area and that a combination of stucco, glass and brick better fits in with the Route One corridor. The owner said they submitted a brick, colonial type of structure and the ARB told him such attempts at historical facades look "hokey" and that today's glass and stucco designs are tomorrow's historical buildings.

While I may have been inclined to question the explanation of a developer for the stucco and brick mix standard interstate

struction or historical look of the new hotels in our historical overly district may be placed upon our own ARB.

In other business, we also approved a new monopole (cell tower) that will look like a very tall tree at the George Washington Recreation center across from Mt. Vernon High School. The applicant is T-Mobile but the pole can serve up to five separate carriers and under the law, if a carrier pays the fee, they must be given a space on the pole if available.

While I was hesitant about monopoles due to concerns about health risks, it was pointed out to me that a monopole that looks like a very tall tree has been in place at Mount Vernon Estate for 12 years. Also, many of our senior members of the committee are retired military folks and according to those members, the same technology has been used by the military for many years and they strongly believe the health risks we hear about are greatly exaggerated and most are not based upon facts. I deferred to their knowledge and voted to approve it. It passed unanimously.

Finally, our beloved McDonalds at Cooper Road and Route One is applying for a special permit for a new drive thru. The big news is the new drive thru will be attached to a brand new building! They are proposing to demolish the existing building and construct a new building. It will still be a McDonald's, only we will have a new building. We did not vote on this proposal as the owner is not yet prepared to go before the planning Commission. The owner assured us that if his proposal does not come to fruition for any reason, the current building will be renovated and the McDonald's will remain on the site.
