

### **Traffic and Transportation**

A lot of interest was generated over the past year with the construction activity occurring at the Mount Vernon Circle and parking lots. The reconstruction of the median and circle was part of a project that began last March and was performed to reconfigure traffic through the Mount Vernon Circle, extend the Mount Vernon Trail, resurface existing parking lots, add 150 parking spaces for visitor use in a new lot, and improve visitor access. The construction included grading, pavement resurfacing, utility and drainage improvements, a trail extension and a sidewalk addition. Here is a summary of the improvements completed for the circle and parking lots.

*New Parking Lot:* The 150-space lot is located west of the existing northside-of-west parking lot.

Existing Parking Lots: Resurface and restriping.

*Route 235 Intersection:* Resurface, new crosswalks and enhanced vehicle and pedestrian signage.

*Mount Vernon Circle:* Dedicated bus drop-off lane, improved drainage and resurfacing.

Mount Vernon Trail: Extend the existing trail along the west perimeter of the east parking lots (adjacent to the east side of the George Washington Memorial Parkway), and direct pedestrian traffic to use the trail rather than cutting through the parking lots.

# **Planning and Zoning**

In my last article I shared the news that a new development is being proposed at the corner of Beulah Road and Telegraph Road. Among other stores, the anchor store planned is a Wegman's grocery store. The needed amendment to the Comprehensive Plan was passed and on March 9, 2009, the Board of Supervisors will vote on whether or not to approve the development. The Planning Commission has already approved the rezoning but the Board of Supervisors has the final word. Currently, the parcel is predominately used as a landfill and is operated as the Hilltop Landfill.

Please note that the great majority of this large parcel is located in the Lee District and the Lee District Land Use Committee approved the plan by a large margin. The Mount Vernon Council (MVCCA) voted 12-10 with 3 abstentions not to oppose the Hilltop rezoning. It looks like Hilltop will soon be getting a new Wegman's grocery center and office building.

In other news, the controversy surrounding North Hill continues as Spring Bank neighborhood, located next to Chuck E. Cheese and near Penn Daw submitted a resolution to the MVCCA to undo the North Hill compromise and suggested the county use the HUD funding it received 25 years ago for the North Hill low income housing project to buy up foreclosed properties and use them for low income housing. No details were provided as to how the county would achieve or administer their

suggestion. The main thrust of the resolution, in my opinion, was to voice their continued opposition to the county's plans to locate manufactured homes on North Hill.

It should be noted this project has a 25 plus year history and some families have been waiting in line that long. Two years ago, the MVCCA reached a compromise on North Hill. It was decided about one third of the parcel would be used for low income housing that will be in the form of manufactured homes and the remaining land will be left as open space. Environmentalists and others have consistently opposed the project.

North Hill is located on Route One across from Denny's and beside the Crown Gas Station. It is the vacant parcel on the right side of Route One if you are headed north, about one half mile before you reach Lowe's. It should be noted that the open space that appears to be wooded forest is actually the home to remnants of a former mobile home park. It still has asphalt roads, concrete trailer pads as well as electrical and water outlets on the parcel. None of this infrastructure was ever removed.

That's some brief news from planning and zoning. Let's all look forward to longer days and warmer weather - it's just around the corner!
