



Transportation

nce upon a time, there was, in the far northern reaches of a land known as the Old Dominion, an exceedingly dreadful and dangerous road known far and wide as the Olde Richmond Highway. This path, while lined in a few spots by respectable merchants and tradesmen's shops, was bounded by sundry hovels in various states of decay, including half-ruined inns, notorious alehouses, and rough shanties where fortune-tellers and soothsayers plied their craft. So densely cluttered were the fringes of the Highway with all manner of hawkers and peddlers, it was said that a traveler from the far southern kingdoms might easily, in the span of merely half an afternoon's passage of the sun across the celestial sphere, eat his fill of the savory foods of his homelands whilst having a cartwheel repaired by one of the many tinkerers and sending the coin of the realm by way of a moneychanger to the traveler's home village, and even still find a moment to haggle with the proprietor of a local pawnshop over the price of a second-hand bauble. Apart from the bustling mercantilism that characterized the Highway, legend has it that visitors and citizens alike so often found themselves mired in endless traffic that they appealed to the leaders of the realm for relief. A planned expansion of the fortress on the border of the hamlet of Mount Vernon caused the scales to tip – some say in favor of the denizens of the realm, others claiming it would be the local rulers, purveyors of paving stones, and distant landlords who would force a pretty penny from the realm's treasury for a slice of their squalid lands, that would handsomely profit from the project. In any case, the people called for help, and their cries were answered by a powerful sorcerer who held temporary sway over the district and who promised, in exchange for the continued support of all the good people in the realm, to relieve them of this scourge of traffic and blight by showering the region with 150 million gold crowns for improvements . . .

From what I recently heard from the Mount Vernon Council of Civic Association Transportation Chair Catherine Vorhees, representatives of county government recently presented preliminary design plans for improvements to US Route 1. These plans are preliminary only, as funds are not yet available in spite of what has been heard from Congressman Jim Moran, who has apparently amassed \$150 dollars for the planned improvements. Due to the complex nature of the appropriations process at hand, the sum is presently secured in an operations and maintenance account, and must be transferred to a "multiyear" account by September 31, 2010 to ensure funding for any finalized plan for improvements to our portion of the Route 1 corridor.

Fort Belvoir appears to have committed in writing to the general, tentative, as yet unfunded, plan, but right of way has not been obtained. Starting at the Fairfax County Parkway and going north, the present design calls for 158 feet of right of way, plus right of way for curb cuts. The county's request for a total of 179 feet of right of way, to be granted by Fort Belvoir was not something that Fort Belvoir agreed to, as there was no desire to part with such a large swath of land. However, the 158 feet as planned feature six lanes, and a median reserved for light rail or regional transit bus lanes. A sidewalk is planned for one side of the road, and a trail planned for the other side.

A centerline chosen was based on Fort Belvoir's desires, so most of the widening is occurring to the west of the current footprint of Route 1. Canterbury Apartments, Hess filling station, a recently foreclosed apartment building, Burger King, and the remaining small business strips along that portion of the corridor would be paved over. Fort Belvoir will build the bridge that Gunston Road crosses to accommodate 6 lanes of traffic. The Woodlawn Trust is silent with regard to the scope of the project thus far. Apparently, Supervisor Hyland asked that the entrance to Woodlawn stables be moved from its location on Route 1.

The cost estimate for the work from the Fairfax County Parkway to Mulligan Road is now about \$142 million, including the acquisition of right of way.

Neighborhood Watch

The Mount Vernon Civic Association neighborhood area has the lowest crime rate in the region. The main reason for this is location; and the other two are spelled in the same way.

Nevertheless, as we enter the summer season, we need to raise our security awareness. Our nightly volunteers report that they are finding some signs of complacency: unlocked garages and unsecured gates. There are some signs of late-night prowlers on our streets and clubs.

While some of these are unsupervised youth not likely to major mischief, there have been a few incidents that are very troubling and call for constant vigilance by every responsible citizen.

Burglaries

Between the February snow and early April, there have been several burglaries at the Mount Vernon Yacht Club. A total of fourteen boats have been broken into, and valuable electronic equipment and other fittings stolen. Many of the boats have suffered serious damage—canvas and glassine ripped and slashed—evidently with knives or box-cutters. Some of the damage goes beyond what might be considered necessary for the trade of thieving; but some of it is the expression of the mentality of vandals. The prospect of armed intruders coming onto private properties late at night is alarming and poses a threat to everyone in the vicinity. It must be stopped.

The club is investing in a high fence, secure gates, and surveillance cameras. Meanwhile, the Wakenhut security company has been engaged to mount a nightly watch. In the few weeks

since they were hired, they have intercepted five or six small groups of intruders, in the after-midnight hours.

Volunteers Mean Prevention

For our part, Neighborhood Watch is asking, again, for more volunteers, so that we can have two patrols each night rather than the present one. The neighborhood is being divided into two areas, divided by Robertson and the Mansion House Clubs. Volunteers who have memberships in the Mansion House and Mount Vernon Clubs and therefore have respective property rights to enter these facilities would be especially welcome. Our unscheduled appearance—especially during the wee-hours and paying special attention to the clubs, the Washington Mill School and Park, and the Methodist church lot—would help contain this new threat to our security.

We are “covered” until early May; but in order to maximize our appearances, I am asking anyone who can contribute about 35 minutes per night, for one week between now and the Fall, to contact me about adding you to our list.

Education

FCPC Priority Schools Proposal

Fairfax County Public Schools has published a Public Schools Proposal. This is part of their commitment to close the achievement gap. The district will identify a specific number of schools which will be deemed Priority Schools. This designation will provide schools with additional support in order to meet their benchmarks for student achievement.

Under this program, schools that are identified will be provided support in the following areas; Division Leadership, School Support, Priority Staffing, Instructional, Principal Leadership Training, and Partnership Assistance. Selection for this program is based on SOL progress, Annual Year Progress status, and a School's Support Composite Index (SSCI). The SSCI is based on a formula that takes into consideration three components; school need, student achievement gap, and student need. The school need measure is the percent of a school's membership of students with Limited English Proficiency, plus the percent from low and moderate income families who qualify for fee waivers. These two measures were selected because research has shown them to be most closely associated with student achievement concerns.

How does this affect our schools in Cluster IV? Our schools were ranked in priority with other FCPS schools with respect to need as follows: Mt Vernon High School was ranked 6th, Whitman Middle School was ranked 7th, and Washington Mill Elementary School was ranked 26th.
