#### **Planning and Zoning**

Spring is coming, REALLY, so just hold on. Until it actually arrives, read about the issues discussed at the P&Z committee.

#### **Lorton Landfill Plans**

One of the biggest is the extension of the Lorton Landfill beyond the 2018 closing date and the subsequent construction of Green Energy Park, a reusable energy park, by ESI, Inc, under their Special Exception Amendment (SEA) 2, if approved. It would have four modes of reusable energy: wind turbines, geothermal exchange, solar panels, and methane gas exchange. Because of its wide impact, the three committees of P&Z, E&R, and Transportation Committees held a joint meeting Feb 19 to discuss the project and develop and pass a Resolution. As a group, the resolution to oppose this effort and to hold Furnace Associates, Inc. to its first SEA was supported. The specific resolution is on the P&Z page of the MVCCA website. Also on the P&Z page are the numerous petitions/letters of support and opposition.

Secondly, under the Laurel Hill Adaptive Reuse (Lorton penitentiary) project, the developer, Alexander Company, Inc., for the retail side of the project briefed us on their plan for the 110.000 SF (max). One of the challenges they face is how to handle the wall surrounding the property. Historic standards require the wall to stay as is and so will block visibility of any/all retail in the area. They're on their third review and are hopeful this one will qualify. The range of retail they are looking for is: high end grocers, clothing store(s), coffee shop(s), and real estate office(s). The specific space detail is: penitentiary area: office/retail/residential, dining hall: office/retail, and northern penitentiary yard: new retail construction. There is a gap of \$10-15M for the project so the Alexander Co is applying for both state and federal historic tax credits to help close the gap.

#### **Affordable Housing**

Another subject briefed was the Review of the Countywide Policy for Affordable Housing Contributions by Non-Residential Developments, AKA 3-2-1 policy. Long title isn't it? The longer explanation (titled AH Contributions Policy.pdf) is outlined on the P&Z page of MVCCA website. Basically, the contribution is tiered: \$3/ nonresidential SF in the Tyson's Corner Urban Center and also within a ¼ of any other Transit Station area, \$2/nonresidential SF between a ¼ to ½ mile of any Transit Station Area; and \$1/ nonresidential SF outside a ½ mile radius of any Transit Station Area to the edge of the Transit Station Area, and in all other Suburban Centers and Community Business Centers of the County. Unsure of the direct impact on revitalization on Richmond Highway. A George Mason University

Center for Regional Analysis workforce housing study, commissioned by Fairfax County Redevelopment and Housing Authority (FCRHA) found that FC needs to plan for



availability of affordable housing for full spectrum of the economy.

Tim Sergeant, Residential Studio Unit (RSU) subcommittee chair, briefed us on the most recent proposal update. They are still working the issue but the most recent proposal is on the P&Z web page. Essentially, it would not allow RSUs in residential areas of R-12 and below and Planned Development Housing (PDH) -12 and below. MV area is still subjected to have RSUs in the area. But the proposal is still being worked.

Lastly, Geosyntec briefed us on the structure of the berm that would have surrounded the landfill under SEA-2 (from the first paragraph)

#### **Budget and Finance**

The 2015 Fairfax County, full year advertised budget plan was released on February 25. Here are the highlights.

The advertised budget maintains our tax rate at \$1.085; however, the official advertised tax rate will not be released until March 4. The budget has a projected positive balance of \$10.64 million in FY 2015 and \$13.73 million in 2016. County Executive (CE) Long has adopted a multi-year approach in developing our budgets.

Modest revenue growth is projected, based primarily on the residential housing market projections. Mean assessed home values have increased, so expect an increase in your real estate tax. The average increase is projected at \$331.67.

The County would like to try to broaden our revenue through diversifying its tax collection base. The County would like to increase the commercial/industrial percentage of total real estate assessment base. For full year 2015, its projected at 19.01%. In 1990, it was 26.76%. The County's office vacancy rate is 14.9%, the highest on record since 1991. The office vacancy rate is blamed on the reaction to the defense department budget cuts and restructuring. FC is making efforts to diversify our commercial/industrial away from its direct reliance on the federal government.

Additionally, the argument for a meals tax to further broaden our revenue source would place some of our tax collection on visitors coming from outside the County. It is also my understanding that the meals tax revenue does not factor into the calculations of how much of our state sales tax money we receive back from Richmond.

On the spending side, the Fairfax County School (FCPS) system continues to expand as the schools seem to do more with less. FCPS asked for a 5.7% increase in the transfer, but the County has budgeted for a 2.07% increase. Student enrollments continue to increase. Yet, FCPS is eliminating over 700 positions, increasing class

sizes and making reductions to non-school based funding.

Additional increases in County spending include pay and benefits for County employees by \$29.54 million, capital construction and debt service by \$29.93 million, public safety by \$14.23 million, cost of County operations by \$12.23 million and human services by \$8.50 million. The details of each of these areas can be found online.

In our meeting with CE Long, he was upbeat about our current fiscal environment. The federal budget negotiations have eased pressure on our local economy and the US economy appears to be on the upswing. Also, the State transportation funding package was approved in Richmond, so FC should see a significant increase in money for transportation infrastructure.

For those of you that have made it this far in the reading, fun fact, FC will host the World Police and Fire Games in the summer of 2015. Supposedly, this is one of the largest global events and is even larger than the Winter Olympics. I'm not sure if they are measuring by attendance or participants, but it sounds like a great time and a good source of revenue for FC.

CE Long also discussed the Moody's FC bond downgrade to negative outlook. CE Long noted the Moody's downgrade was due to not enough reserves, underfunded pensions and the use of one time sources of money for recurring expenses. These are being addressed moving forward, but CE Long disagreed with the reserve requirements.

Important dates to remember, March 4th advertisement of FY 2015 tax rates, April 8th-10 public hearings on FY 2015 budget, April 22nd budget mark-up and April 29th, budget adoption. #### **Consumer Affairs**

There has been discussion for some time now to expand the Farmer's Market options for the Mount Vernon area beyond the currently operating location at Sherwood Hall Library parking lot. Front runner for consideration had been the Belle View Shopping Center — good location and far enough from Sherwood Hall that it would present fresh produce shopping at a different venue serving others within the Mount Vernon community. Unfortunately, the owners of the BV Shopping Center voted not to move ahead with the idea, so discussion for other venues has now been reopened. Fifteen possible alternatives were discussed and those narrowed to the five most likely locations. More to follow.

Under consideration at present: Re-laning of the two-lane road in the Sherwood Hall area to

make it a 4-lane road and completely eliminating any roadside parking. Would severely impact SH residents and the businesses and churches in the region. Information meeting to be held at Mt Vernon Government Center, March 12, 6:30pm. We have no problem with proposed re-striping of lanes, but do want a dedicated left turn lane for traffic.

The county would like to establish a Transit Center in the vicinity of either the former Home Goods store in Hybla Valley or the South City Government Center OR the corner of Richmond Hwy and Lockheed where the Shell station is.

#### **Education**

The Fairfax County School Board has adopted the FY 2015 Advertised Budget of \$2.5 billion, a net increase of 2.4 percent, or \$59.4 million, from the FY 2014 Approved Budget.

One of the big drivers of the budget is enrollment and demographics changes within the county. FCPS enrollment has grown by 15,603 students since FY 2010. Looking more closely at the enrollment increase is interesting. The General education enrollment (non ESOL or special Ed) has grow 8.8% since 2010 but the ESOL enrollment has grown by 51.3% since 2010 and now accounts for 14.4% of all students. The special education enrollment has increased by 6.4% since 2010.

These enrollment changes are important from a budgetary perspective since the average cost per General Education student is projected to be \$11, 359 while ESOL students incur an additional cost of \$3,481 per ESOL student. The average cost per pupil for the special education program is \$22,720.

We rely heavily on local funds for our school system. In Fairfax County we receive a much smaller proportion of our education funding from the state than other localities. Fairfax County receives 21.7% of its funding from the state while other school systems on average receive 43.7% of their funding from the state. The state funding level is calculated using the Local Composite Index (LCI). The LCI is calculated through a complicated formula that attempts to determine which school systems can afford to pay more of their own basic education, and which systems cannot afford to pay.

In order to balance the school budget the budget cuts over 700 positions, requires families to pay for AB and IB exams, increases classroom size, and cuts to summer school programs.


