

The 68th Annual Birthnight Supper and Ball will be held on **Sunday, February 15, 2015** in Mount Vernon Estate's Ford Orientation Center. This festive black tie event is the pinnacle fundraiser for the Neighborhood Friends of Mount Vernon, and celebrates the birthday of our founding father, George Washington. As in the past, Mount Vernon expects this to be a sold out event.

This year's Ball will feature a seated dinner by Design Cuisine, one of the D.C. metropolitan area's premier caterers, dancing to the Kevin Kline Band, a special performance by soprano Kellie McHugh, and a cake cutting ceremony with our very own General and Lady Washington.

All proceeds from the event benefit the 2014-2015 Neighborhood Friends sponsored project, Phase II Restoration of the East Lawn Slope. Not only is this a fun and celebratory evening, but it is for a very worthwhile cause. No project can be more important on the Estate than ensuring the stability of the slope on which the Mansion stands. Northern Virginia received historic rain on the August 12, 2014, and while the Phase I remediated northern and southern



sections of the slope held up remarkably well, the powerful storm greatly compromised the mid-section of the slope which had not been restored. A 20 foot wide slide of ground resulted from this 500-year rainfall which wrecked havoc on the natural springs that run under the entre bluff and are surrounded by marine clay soil. Immediate work on this section is now needed to prevent further slippage and damage to the slope.

PLANNING AND ZONING


Happy New Year, one and all. Hope you had a Merry Christmas. To the business at hand. We discussed at length the resolution for funding of Phase 2 for the Route 1 corridor. The single resolution was divided into two parts – giving equal importance to the funding and phasing of the project and allowing an ability to send to different elected officials, if needed. The P&Z and Transportation committees approved resolutions are on the MVCA web page.

We were provided an information briefing on the Morning Star Daycare application as a Special Exception. The proposed address is 8628 Woodlawn Court Alexandria-next to the approved Baywood Hotel on the corner of Richmond Highway and Woodlawn Court. The facility would operate in two shifts: 7:00 AM to 4:00 PM (80-120 children) and 3:00 PM to 1:00 PM (40 children). Both the P&Z committee and the Woodlawn Court residents present shared many of the same concerns traffic flow to and from the facility and at the facility itself. The Committee reserved comment until the concerns have been addressed. The Planning Commission date for this application is January 29, 2015.

Paul Frank, Executive Director, Collingwood Library, briefed us on his proposal to subdivide the Collingwood Library property into two parcels. Justification for the request is that he would maximize profits for the Library by selling the second parcel, on the river side, to one owner. The area is R2. The map, with the current conservation easement, shows a long driveway from East Boulevard Drive, through the property, to a 5000SF footprint for possibly one large home near the Potomac River. Because of the many environmental concerns, we asked that the Planning Commission date be deferred until the Environment and Recreation Committee and Collingwood residents review the application.

Lastly, I've put Supervisor Hyland's Visioning Task Force results on our web site. It's delineated into 1-5 years, 5-10 years, and 10+ years and touches all aspects of living in Mount Vernon; transportation, land use, environmental, etc. If you have an idea, opinion, priority, please let me know. The input will be sent to individual MVCCA cochairs to draft a letter to our elected officials that states the recommendations of importance to the MVCCA from all standing committees.

These two issues do not necessarily apply to membership but are important points to share. The first is that a MVCA member reported that his house (built in 1958) had significant and unknown damage done by the last earthquake. It wasn't until the chimney-sweeper came in this fall that he discovered that his chimney had moved at the roof line and that the internal lining had disintegrated (even with a cap). If you live in an older house and have a fireplace, you may want to contact a chimney-sweep to check out your fireplace and chimney.

Secondly, one of our postal carriers passed on that there are salespeople who are putting fliers in outside-home mail boxes. Besides being illegal it may cover your outgoing mail and therefore mail may not be picked up in a timely manner. The carrier also said if residents see strangers putting fliers in boxes, they should tell them to stop. The carrier said the USPS can't guarantee mail safety if mail boxes are cluttered with sales papers delivered by others.

BUDGET AND FINANCE COMMITTEE

Happy New Year and good luck with all those new (or old) resolutions.

The 2016 budget discussions are just getting started. The County is watching the tax collections and revenue closely. The County tax receipts are down and many are blaming this on the lingering effects of the sequestration and federal budget cuts.

In addition, home values in Fairfax County are lower than projected and job growth is slower in the County. The northern Virginia job market is growing at 0.4% versus 2.0% for the rest of the country. According to County Executive Long "the cornerstone sectors of the local economy—federal government and professional services—are losing jobs." The sectors gaining jobs are lower paying jobs like retail, hospitality and construction and other services.

Home sales are down about 10% through October. Supply of homes is strong, which is adding pressure to valuations. Nonresidential values are flat and expected to fall in 2016. Office vacancy rates are at their highest rate since 1991. There are concerns about absorbing all the new construction related to the Silver Line expansion. All this adds to short falls in revenue projections for 2015 and concerns moving forward.

With budget shortfalls projected in 2016 and 2017 for Fairfax County, we also have State budget deficits.

County expenses are projected to increase by 4.93% in 2016. Most of this increase will go towards the increasing student population in the FCPS system and salary and benefits for the FC employees. Many of these costs are mandatory to cover new students and employee benefit requirements. However, the bulk of this projected spending increase is for market rate pay adjustments for County employees. The 2016 budget shortfall is projected to be \$100 million and about \$79 million for 2017. This year's (2015) budget deficit was projected at \$37 million. We are now running an even larger budget deficit for 2015.

CE Long noted that budget reductions will be necessary to balance our budget. Yet, a slowing economy puts more pressure and costs on our human services budgets. So, as we look to balance our budget, we have mandatory expenses for public school growth and the human services budget expanding. Yet, CE Long will be looking to reduce the overall budget. Something is going to have to give. We will need to be careful of shorting our investment budgets for things like roads and infrastructure or this will have troubling effects on the future.

What does that mean for us? Look for a push for more County revenue in the form of a meals tax or increased real estate taxes. It is unsure how effective further budget cuts will be. Additionally, the County had better keep an eye on our credit rating and being downgraded by the credit rating agencies.

As your humble Budget and Finance Chair, I think we should push for a more diversified economy, continue to fight for more of our share of State money being returned, and have more discussions on the expenses associated with the changing demographics in our school system. Our leaders should continue to support FC's long tradition of growth and prosperity by committing itself to informed and responsible fiscal behavior.

Clear car windows of snow and ice before driving to ensure visibility; keep adequate cold-weather windshield washer fluid level

- Allow extra room for braking on wet, icy and snowy roads; be particularly alert for school buses and their passengers.


