Don't Forget to Register to Vote!

Deadline to register to vote, or update an existing registration: **October 15, 2024** (Voters may register after this date, through Election Day, and vote using a provisional ballot).

Deadline to apply for a ballot to be mailed to you: **October 25, 2024**. Your request must be received by your local voter registration office by 5:00 p.m.

Voter registration offices open for early voting: **Saturday, October 26, 2024**.

The last day of in-person early voting at your local voter registration office: **Saturday, November 2, 2024** at 5:00 p.m.

Airport Noise Mitigation Study and Community Survey

The presence of aircraft noise and the volume of aircraft flying over our community was the subject of a recent presentation to Mt Vernon District Supervisor Dan Storck, Fairfax County Planning and Development Staff, and attending residents on 17 July. At the Noise Mitigation Project- Status meeting, Fairfax County offered the opportunity for Fairfax County residents to respond to a Community Engagement Survey and identify who, how, and when aircraft noise and traffic most affected residents. The survey, which closed 31 July, allowed MVCA and its members to participate by documenting the noise impact across many neighborhoods in Mt Vernon.

The Noise Mitigation Project Consultant, Vianair Inc, for Fairfax County, plans to review the Community Engagement Survey and prepare some structured solutions that will be given to the South of the Airport Community Working Group which accepts recommendations to provide to the Federal Aviation Administration. This response represents the Fairfax County (and Mt Vernon residents') input that addresses concerns for aircraft noise and air traffic (airplane numbers and flight patterns) over noise-sensitive (residential) areas.

MVCA will strive for accountability and tracking of our community input and what the contractor, VIANAIR Inc, provides to the Airports Advisory Committee members for the South of the Airport Community Working Group and the recommendations for FAA action. The next Fairfax County Airport Advisory Meeting to discuss the Community Engagement Survey, including the Mt Vernon input, is now scheduled for 12 November (location to be announced).

Cherrytree Lane Speed Management Update

In May, the proposal for the installation of speed tables and one speed hump along Cherrytree Drive was passed by the residents within the ballot area designated by the Fairfax County Department of Transportation. Once the vote was completed, the results tallied, and results published, the requirements of the Task Force were finalized. The Task Force then suspended their activity.

The final vote results:

Homes in ballot area: 79

Votes required to pass (50% of homes in voting area): 40

Total # of ballots received by Supervisor Storck's office: 65

Duplicate ballots (sent via multiple delivery mediums): 4

Ballots received after cutoff (5pm May 10th): 5

Total # of eligible ballots for tally: 56

Final vote tally number: In favor (Yes): 49

Not in favor (No): 7

At the Board of Supervisors June 25th meeting, the Board approved the measure for the installation of the speed tables and a speed hump on Cherrytree Drive. As a result, the action passed to the Fairfax County Department of Public Works and Environmental Services for action and installation. The notice to Proceed for Cherrytree Drive was produced and the state's installation of the traffic calming devices began on or about September 16th, for the duration is 90 calendar days. The work shall be substantially completed by December 14, 2024. Failure to complete the work within the established duration will incur liquidated damages in the amount of \$350.00 per day.

Please consider:

- Bicycle reflectors and bike lights as well as high-visibility clothing and helmets. Carry ID, plastic whistle.
- Motion-sensitive outdoor lighting and outdoor cameras for homes and garages
- Keep garage doors and parked cars locked.
- Watch for young children in street and near or in curb leaf piles.
- STOP when the school bus RED LIGHTS are flashing. DO NOT PASS. Some school buses also have a folding bar or arm with the Stop sign and some of the arms now have cameras.
- Do not pass a stopped school bus as the bus driver may be able to see something or someone that you do not.
- Some jurisdictions are using SPEED enforcement cameras, including the City of Alexandria.
- Check batteries in smoke detectors and flashlights as well as the readiness of fire extinguishers, Have a fire escape plan and family meeting place. Call 911 when Police, Ambulance/Rescue, or Fire Department response is needed. Be specific about your location and address.
- Report Downed Electrical lines to 911 and Dominion Energy. Emergency Numbers are in the back of your MVCA Directory.
- Keep a battery-powered radio on at times of high-winds, road flooding, etc. We have had recent close calls in Northern Virginia this year.


