## PRESIDENT'S MESSAGE

Dear Mount Vernon Civic Association Members:

In 2019, MVCA was asked to help refurbish aging entrance monuments in our community. At our March 11, 2020 MVCA meeting I presented a proposal to accomplish this and it was overwhelmingly approved. We also thank our past MVCA President, Sean McCarthy, who led this effort and many of you who contributed \$2,500 to start these projects.

### The Project Process

Our first project was to remove the crumbling brick from the Yacht Haven monument at Ferry Landing and Forest Haven Roads, grind out the old mortar, replace it with new brick, power wash and repaint it. We also power washed and then repainted the Yacht Haven monument at Ferry Landing and Neptune.

The cost for both projects totaled \$1,922.41. We thank Dick and Suzanne Floyd and John Skudlarek, the property owners adjacent to the two monuments, for providing the upkeep to these monuments for many years and allowing us to use their water and electricity during the refurbishing. We also thank Denise Wight and the Yacht Haven Garden Club for their beautiful plantings and care and for Peter Esser's help painting.

Our next project was to refurbish the two Mount Vernon Forest monuments at Mount Vernon Memorial Highway and Cherrytree Drive. Our original contract of \$2,110,00 paid for the removal of the extensive overgrowth and the cutting down of trees around the right monument and the power washing and replacing mortar on both monuments.

Once the vegetation was removed, we found that there was extensive damage to the right monument.

Andrea D'Ambrosia Dolan took the lead and contacted community residents. They came to a consensus to have a mason remove the broken parts of the right monument, repair it so that the brick matched and put a footing under the right side of the monument. This additional repair cost \$1,000. Community members contributed \$1,790 for this work plus funds for new plantings. Pam O'Meara also helped raise the necessary funds.

We thank Greg Dolan and Steve Ayers for doing the hard work of removing broken electrical poles and wiring and ground preparation. We are also grateful for the adjacent landowners, John and Eileen Hurley and Gianna Yurko, for providing the upkeep of the monuments for many years and allowing us to use their water. Andrea created a new planting design and Kevin Diana and Greg helped her with the replanting.

We just received an estimate of \$3,800 to replace the mortar and power wash the Westgate monument at Mount Vernon Memorial Highway and Old Mount Vernon Road, our final refurbishing project. We are grateful that Andrea has agreed to also lead the planning and fundraising of this project.

### What's the Difference Between a Gaiter and a Mask?

As COVID-19 pandemic continues to create havoc in our daily lives, the face mask has become a hot commodity and at times a fashion statement. We've seen micro trends related to masks, most from luxury designer mask or perfectly matched mask and outfits. While we all (should be) wearing masks, a new trend appears to be emerging, gaiters.

My seven-year-old daughter came home from school with a note stating gaiters are required and face masks are not being used until further notice. My first reaction was complete bewilderment. I spent approximately \$100 on a face mask for her, and now I'm being told this is not effective? I immediately went on Center for Disease Control (CDC) website to find out what is the difference between a gaiter and a face mask? And do gaiters provide better protection than face masks?

To my surprise, I discovered two things: 1) the only differences between the face mask and gaiter is comfort, and 2) the gaiters are under tremendous scrutiny. Face masks have loops around the ears

and can be easily pulled up and down to cover and uncover the mouth and nose as desired. Whereas, gaiters are tubes of fabric that you slip over your head and pull up over the nostrils and mouth, avoiding your ears. Gaiters can be made of any fabric that is comfortable.

The controversy surrounding gaiters began with Duke University. Duke conducted a study and concluded in a report on August 7, 2020 that gaiters are not effective. Several researchers, not affiliated with Duke University, came forward and disputed the study. These researchers stated it is not the gaiter itself that is the issue, it is the type of fabric being used for the gaiter. Dr Jason Kessler from Morristown Medical Center in New Jersey says gaiters made of higher thread counts, made of cotton appear to block more respiratory droplets than those gaiters made with lower thread counts. He further stated there is not enough evidence at this time to conclude gaiters are more effective than face mask or vice versa.

Before I attempt to email my daughter's school to request a choice be given between a face mask and gaiter, I am going to wait for CDC's next report in November 2020. Rumor has it, this report will stop the gaiter and face mask debate. I hope that report says both are effective in stopping the spread of COVID-19.

## BUDGET & FINANCE REPORT

Where is your money going? Two major funds were allocated this year that impact our neighborhoods.

First, we are looking at improvements to the George Washington Memorial Parkway. Over the summer, the U.S. Senate passed the Great American Outdoors Act, legislation that was co-sponsored by 60 senators including Senator Mark Warner. The GW Parkway has suffered from years of deferred maintenance to the tune of almost \$300 million. The Great American Outdoors Act will provide approximately \$6.5 billion over the next five years toward all national parks, which include GW Parkway. Specifically, GW Parkway can anticipate road type repairs, visitor centers improvements, and trail repairs.

Second, did you know that our gas taxes are increasing? The Virginia General Assembly voted this spring to increase the gas tax for all of Virginia. The gas tax will increase five cents over the next two years and is expected to yield a revenue to \$1 billion. The gas tax is expected to utilize the money to repair old roads and improve passenger and commuter rail service throughout Virginia. The ultimate goal is to improve the VA economy, reduce congestion, and utilize rail service at higher rates.

## Public Safety

*Fall brings the need for better attention to safety and fire/traffic accident/crime prevention in the darker hours both morning and late afternoon/early evening.*

Some thoughts:

- LOCK parked vehicles.
- USE motion-sensitive outdoor lighting.
- KEEP garage doors locked.
- BE exceptionally careful when driving near school buses and school bus stops.
- SOME areas of Route 235 (Mt. Vernon Memorial Highway) are now 40 mph, others are 45 mph.
- NUMEROUS safety aids (helmets, reflective clothing, vests, improved fore and aft lights for bikes, bells, reflectors on bike tire sidewalls).
- AS leaves fall, be ready for slippery spots and children playing in or near leaf piles in the street.

-REMEMBER many of our blocks do not have sidewalks at all or only on one side.

-CARRY a cell-phone, whistle and flashlight on walks and runs particularly in hours of darkness. Consider wearing reflection vests.

-BE sure your home heating system, chimney(s) and fireplace(s) are ready and safe for fall and winter. Dispose of ashes with care.

-FRESH batteries in smoke, fire and carbon monoxide detectors.

-IDENTIFY an area in your home as a tornado shelter.

-HAVE an escape plan in the event of fire AND also a nearby agreed-upon meeting point.

In an ordinary school year FCPS would adjust preliminary staffing levels based on actual enrollment as of September 30. However, in this pandemic year this process may result in significant loss of teaching positions at many schools. Many schools' enrollments are down, and in the usual year would result in the loss of teaching positions. However, this is far from an ordinary year and, if FCPS is able to begin in-school instruction, more teachers, not fewer, will be needed. The Mount Vernon Council of Citizens Associations, in the interest of promoting the least disruptive educational experience for students in the Mount Vernon District, has indicated their support to the Fairfax County School Board to "hold harmless" schools which have suffered enrollment decreases.
