1. Renter acknowledges receipt of the equipment identified above (the "Equipment" which was examined by Renter and found to be in first-class condition upon receipt (except as noted below). Renter further acknowledges that the equipment is Rented for the use and purpose for which it was manufactured. however to the terms and conditions set forth herein. Renter & Owner will note all previous damage location and description on bottom of last page.
2. Renter shall return the equipment to the owner no later than the date and time specified above (RENTER SHALL CONTACT OWNER IF AN EXTENSION OF TIME IS DESIRED). The equipment shall be returned in the same condition as when received, ordinary wear accepted. Ordinary wear & tear of tires is ok. If Renter has a flat tire due to puncturing a tire with a foreign object ( nail, screw, rebar, etc.) Renter is responsible for providing a new tire or Owner Will Charge Credit Card On file.
3. Renter shall pay to Owner for the equipment at the rates provided above until the equipment is returned to Owner. Daily rates will apply unless other arrangements are made with Owner in advance. Daily rates will apply if the equipment is kept after the scheduled return date Or Hour Meter Reading. All days including weekends and holidays are chargeable.
4. Renter shall reimburse Owner, upon demand for the loss of, or any damage to the equipment or property damage while it is rented to Renter and for all costs and expenses, including reasonable attorney's fee, incurred by Owner in collecting and amounts owing by Renter here under or in otherwise enforcing Leaser's rights. Renter shall be responsible for any tow fees or impound fee resulting from misuse or breaking the law.
5. Renter shall identify and hold Owner harmless from and against any an all liability, including bodily injury, Self Harm, property damage, Fines, Medical Bills, Legal Fees arising out of the use, Misuse, operation Or Equipment Failure of the equipment by Renter or anyone using or operating with Renters express or implied consent provided. However, the Renter shall be responsible for loss or damage resulting from Renters sole negligence.
6. Renter shall abide by all rules and regulations of Owner governing the use of the equipment. (ONLY HOLDERS OF A VALID DRIVER'S LICENSE 18 YEARS OF AGE AND OLDER MAY OPERATE THE EQUIPMENT).
7. Renter shall not assign the Rental Contract or sublease the equipment.

## Equipment Rules

- Renter of Equipment shall abide by all proper instructions & restrictions listed in owners manual of equipment Rented
- Renter CAN NOT exceed proper payload, Lift limits, Weight limits the manufacturer states on Equipment Rented.
- **REPORT ANY & ALL MALFUNCTIONS TO THE OWNER IMMEDIATELY VIA TEXT, EMAIL OR PHONE CALL.**
- Renter Must Load, Transport & Secure all Rental Equipment with Proper Equipment.
- Renter has noted all existing visible damage.
- Battery maintainer must be plugged in during a multi day rent (if equipped).
- Normal wear & tear is acceptable.
- If Equipment is Covered with mud, debris or liquid. Renter will need to spray down the Equipment..
- Normal dirt & dust on the equipment is acceptable.
- Renter is NOT responsible for lubrication of the Equipment or hydraulic system unless the Equipment is rented for an extended period of time (4 Days or longer).
- All Equipment Should be filled with the proper Gas Or Diesel Prior to return.
- **Fuel will be charged at \$6.00 Per Gallon** if Equipment is returned with less than a full tank.
- Renter will not be under the influence of any Illegal drugs or alcohol while using this equipment.
- Anyone found abusing the rules & regulations of this rental form would forfeit all rental privileges. There will be no refunds made if the Equipment has to be returned because of renters misuse. Loss of damage deposit will also result if the Equipment is misused or damaged, There are NO second Chances.
