

RANGE RULES FOR MISFITS SHOOTING RANGE LLC

Located at 30860 Nichols Sawmill Rd.

The purpose of this club is to have fun, and enjoy others with
the same values AND DO IT SAFELY.

It is a private club

NRA MEMBERSHIP REQUESTED

This club is owned and operated by James Lynn Evans
aka Whiskers.

Everyone will be treated equally and fairly.

SAFETY IS OUR PRIMARY CONCERN

SAFETY is the first rule in all aspects

1. **FIREARMS**: Every firearm will be treated as if loaded at all times whether it is or not.
2. **OPEN ACTION RANGE**: No actions closed behind the firing line on any gun.
3. **ALCOHOL AND CONTROLLED SUBSTANCES**: No alcohol or controlled substances are allowed on this range. No person using alcohol or controlled substances is allowed on this range. Any member caught on this range violating this rule will be immediately removed from the club with no refund of dues or fees.

4. EYE AND EAR PROTECTION: Eye and ear protection required at all times when on or near firing line.
5. TIMES OF SHOOTING: Practice shooting is from the hours of 9:00 AM till dusk Monday Thru Sunday. NO person is allowed on the property except during the above times except on scheduled event days. Then the arrival time is not before 7:00 AM and everyone must vacate the property by dusk.
6. FEES: A fee will be paid in the amount of \$10.00 (ten dollars) per day per person for practice, \$15.00 (fifteen dollars) for guest. Scheduled shooting day fees are \$15.00 (fifteen dollars), guest fees are \$20.00 (twenty dollars)
7. TRASH: Any member using the range will be responsible for removing their trash from the range and the property.
8. AMMUNITION: All ammunition used on steel targets will be lead bullets only, no jacketed bullets or gas checks on steel targets. Velocity restricted to 1000 fps for handguns and 1300 fps for lever action rifles and 1500 fps for single shot rifles. There is also a minimum velocity of 600 fps, or published loading data, for all ammunition. Jacketed bullets are allowed on paper targets (targets supplied at the shooters expense). A chronograph will be used if there is a question about your loads.
9. TARGETS: All steel targets will be engaged in a line perpendicular to the firing line plus or minus 10 degrees. Pistol targets (blue) are for pistol only. Rifle targets (red) are for pistol or rifle. Shotgun targets (black) are for shotgun only. White targets are for long range rifles. Orange targets are for any type bullet at ranges of 50 to 200 yards. Please no steel targets closer than 50 yards for jacketed bullets. Any damage caused by improper use of the targets will be the responsibility of the person damaging the target. It must be repaired or replaced. Under no circumstances will any steel target be closer than 25 feet from the firing line.
10. AGE REQUIREMENTS: All persons under 18 must be supervised by a parent or guardian AT ALL TIMES. No exceptions.
11. MEMBERSHIP: Any person applying for membership must be a citizen of the USA, of good moral character, not restricted from purchasing or owning a firearm by any local, state, or federal law. Any person may be rejected for

membership if the owner deems them to be unsafe in any way.

12. DUES: See fee schedule below

13. LIABILITY RELEASE: All persons on this range will be required to sign a liability release even if they are not shooting.

14. GUEST SHOOTERS: A person may shoot as a guest at any scheduled event or with a member on practice days (no more than 2 guest per member). Guest may be refused access to range by any person of authority for any valid reason such as safety, incompetence with a firearm, rude or disrespectful behavior, possession of an illegal weapon, alcohol or controlled substance.

15. RANGE OFFICERS: Only persons approved by the lessee, James Lynn Evans aka Whiskers or his designated representative, may be range officers (run the timer) at a scheduled event.

16. HOLSTERS: NO FAST DRAW ALLOWED ON THIS RANGE

17. DISAGREEMENTS: Any person having a disagreement with another person will have to resolve the dispute quietly or leave the range. Any outburst of temper or violence will not be tolerated. The person or persons involved will be asked to leave. Two such violations by one person will be reason for dismissal from the club with no refund of fees or dues.

18. PERSONS OF AUTHORITY: A list of persons having authority over this range will be posted at the range.

Failure to observe any of these rules can lead to dismissal from the range and revocation of membership with no refund of dues or fees.

These rules can be modified at any time for any reason. Members will be notified of changes by e-mail and on the website links.
