

COVID-19 INFORMED CONSENT

XL Sports is taking reasonable measures to prevent the spread of COVID-19 infection, including tracking/tracing, and following applicable state and County public health orders and protocols. However, the possibility of transmission cannot be eliminated. Athletes and their families must be aware of and acknowledge the risks before participating in athletics.

By signing you acknowledge, accept, and agree to all the following:

- 1. Participation in the 2024 Football Seasons are purely voluntary.
- 2. Youth Athletes have permission to participate in the 2024 Football Seasons.
- 3. Youth Athlete will comply with league and team protocols for tracking/tracing/reporting
- 4. The Athlete will not attend the event if any of the following apply:
- 5. The Athlete or any member of his/her household is exhibiting one symptom(s) of COVID-19 that first appeared within the last 10 days:
- 6. Fever (at or over 100.4°F or 38°C) chills, cough, shortness of breath and or difficulty breathing, feeling tired, muscle or body aches, sore throat, nausea or vomiting, diarrhea, congestion or runny nose, or new loss of taste or smell. The Athlete or Parent/Guardian, if the Athlete is a minor, will check Athlete's temperature at home prior to attending the event and Athlete will not attend if he/she temperature is at or over 100.4°F or 38°C.
- 7. The Athlete or any member of their household has been diagnosed with COVID-19 or has a suspected diagnosis of COVID-19 or pending COVID-19 test.
- 8. The Athlete or any member of their household has spent time with another individual who has been diagnosed with COVID-19 or has a suspected diagnosis of COVID-19.
- 9. The Athlete or any member of their household is currently under isolation or quarantine orders.



- 10. If the Athlete tests positive for COVID-19 or has been identified as being exposed to an individual that has tested positive for COVID-19, the Athlete or Parent/Guardian, if the Athlete is a minor, agrees to immediately inform XL Sports LLC. Officials and acknowledge that the XL Sports LLC Officials must contact the Hawaii State Department of Health, (SOHDH) to provide information regarding the confirmed positive test, including Athlete's name and contact information. I consent to XL Sports LLC. providing such information to SOHDH or any other administrative body as required by law. I agree to willingly cooperate with any contact tracing that is deemed necessary by the XL Sports Officials and or SOHDH.
- 11. We are aware that the Athlete may be exposed to COVID-19 while participating in the 2021 Summer Football Season. We understand that this exposure carries a risk of infection, serious illness, or death for both the athlete and their household members.
- 12. We acknowledge XL Sports LLC., City and County Parks and Recreation, Saint Louis School, the SOHDH or other administrative body with authority may determine to cancel the event at any time. We acknowledge XL Sports must comply with any mandates issued by any entity with the authority over athletics and agree to comply with any such directives even if issued after signature to this agreement.
- 13. Athlete and Parent/Guardian, if the Athlete is a minor, is/are aware that the practices and games will look different from normal pre covid events, including the need for physical distancing and the correct and consistent use of face masks. We agree to comply with the direction provided by XL Sports or team staffing and acknowledge that the failure to do so may result in the Athlete being refused participation at the event.
- 14. Athletes are voluntarily participating in athletics. Athlete or Parent/Guardian, if the Athlete is a minor, agrees to assume all risks of infection, injury, or death, whether those risks are known or unknown.
