## Letter from the President

You may have noticed the large balloon flying over the church at 6400 Old Centreville Rd. The balloon was to test the visual impact of the proposed 88' stealth bell tower for AT&T's proposed wireless tele-communications facility. The facility will allow AT&T and at least two other wireless carriers to provide emergency and non-emergency wireless service to the area. The location was chosen to minimize visual impact in the area.

Homes are selling well in the community. It is a good time of year to look at your home and any potential maintenance issues. Check your roof, siding, rake board and trim. Is it time for that new garage door? Check your landscaping. Does it need to be trimmed back or even replaced in the spring? January is a good time to trim trees. Please do not top them - it just weakens the trees and may even kill them.

## Dear Store House Drive, Sutler Store Court, and Store House Court Residents:

Several residents have complained about speeding vehicles in the neighborhood. To address this problem, Centre Ridge Regent would like to be included in a Traffic Calming Program operated by Fairfax County Dept. of Transportation. The goal of the program is to "develop traffic calming plans that enhance public safety, uphold standard traffic engineering principles, reflect community desires, and are financially responsible."

A request must be made by the HOA to initiate this program. The program requires community members, usually 4 or 5 residents who can serve as community task force members. One person needs to serve as lead contact for the task force. The task force responsibilities will include:

- \* Informing the community of the request.
- \* Providing expectations to FCDOT prior to the development of the traffic calming plan.
- \* Review and approving the conceptual traffic calming plan.
- \* Securing property owners' signatures.
- \* Building community support for the plan.
- \* Distributing ballots if not mailed by Centre Ridge Regent.

If you are willing to serve as a task force member please contact Mary Lynn Sallette at 703-968-7505 by March 1, 2021. If no one volunteers, Centre Ridge Regent cannot move forward with a request to Fairfax County Department of Transportation for this program.

Due to the coronavirus, most of this work would be done by mail through the HOA. I look forward to working with you to resolve the speeding issue.

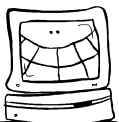



## Towing Company

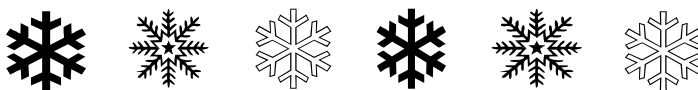
Battlefield Towing (703-378-0059) is the towing company for Centre Ridge Regent.

- ◆ Do not park in the fire lanes or streets of the townhomes.
- ◆ Do not leave cars unattended in these areas.
- ◆ Do not park in residents' assigned parking spaces.
- ◆ Do not park in spaces over 48 hours
- ◆ Vehicles must be current on license plates and inspections.
- ◆ Do not park vehicles angled in front yards or blocking the sidewalk or street.
- ◆ Do not park commercial vehicles (vehicles with logos, box trucks, vehicles with ladders or racks) in driveways or in the guest parking areas of the townhomes.

# Centre Ridge Regent Dog Park Rules

Hours of Operation: 7:00 AM - 7:00 PM

No more than 10 dogs allowed at a time

- \* Only for use by Centre Ridge Regent residents and their guests.
- \* Handlers must be 18 years of age or older.
- \* No person under age 16 allowed in the park.
- \* Handler is limited to a maximum of 2 dogs.
- \* Dogs must be legally licensed and current on vaccinations, and shall wear a visible dog license.
- \* Dogs must be at least 6 months old.
- \* All dogs must be spayed or neutered.
- \* All dogs must be on leash when entering and exiting the dog park.
- \* Dogs must be within sight and under voice control of owner at all times.
- \* No food — training treats are permitted.
- \* No drinks in glass containers.
- \* Owners must collect and dispose of all dog waste.
- \* Dogs showing aggression toward people or other animals must be removed from the park. Animals that exhibit a history of aggressive behavior will not be permitted to enter.
- \* Owners are legally responsible for their dogs and any injuries caused by them.
- \* Animals other than dogs are prohibited.
- \* Violators will be subject to removal from the park and suspension of park privileges.
- \* Users of this facility do so at their own risk. Centre Ridge Regent shall **not** be liable for any injury or damage caused by any dog in the off-leash area.



# Zoning Modification Project

Fairfax County is making major changes to its Zoning Ordinance. A Planning Commission public hearing is scheduled on January 28, 2021 and a Board of Supervisors public hearing is scheduled on March 9, 2021.

This is known at the Fairfax County Zoning Modification project or “zMod”. The project is to revise the zoning process and make the process easier to understand and to use. Some of these changes could have a major impact on our community.

Some the proposed changes are:

1. Increasing the types of businesses allowed to be operated in a home, increasing the number of customers allowed to visit, and allowing online and offsite retail businesses to be conducted in the home, and
2. Expanding the use of Accessory Dwelling units by eliminating the over 55 or older requirement or for disabled residents and simplifying the review and approval process.

These proposals may have a significant impact on our community due to:

- a. increased demand for parking, trash removal, and use of amenities.
- b. Increased traffic in the neighborhood.
- c. higher insurance costs.
- d. possible increase in membership.

These changes could mean that Fairfax County may approve having an additional detached dwelling in a back yard.

\* Do not build steps or walkways in the common areas.
