1. Remove existing Roofing to wood  
2. Replace any rotted wood or damaged wood with plywood at \$90.00 per sheet of 1/2" or \$110 per sheet of 3/4", Fascia wood \$15.00 per foot, and rafter Replacement or sistering \$225.00 each above the cost of roof. If plywood overlay is required due to widely spaced slat board, the cost of the 3/8" plywood per sheet installed is \$65/ board.  
3. Back Nail all Plywood  
4. Ice and Water Shield 3 feet on all drip edges, walls, chimneys and valleys  
5. Install synthetic felt on balance of wood  
6. Install new aluminum drip metal on all eaves of roof deck  
7. Install new aluminum rake metal on all outside rake edges  
8. Install new vent pipe boot flashings  
9. Install new chimney flashing (if applicable)  
10. Install new architectural lifetime shingles  
11. Install ridge vent on all ridges  
12. Install Ridge Caps  
13. Haul away all Roofing debris
