To Whom It May Concern,

I am writing to request that, if possible, you please expedite  
the processing of the 1023 application for 501c3 tax-exempt  
status for the above identified organization.

This request for expedited processing is being humbly submitted  
to you now as receiving the 501c3 tax exempt designation as  
quickly as possible would greatly enhance our ability to carry  
out the initial focus of our not-for-profit, which is to help  
Doa'a Al-Dalou (a young lady living in the Gaza Strip of  
Palestine) travel to Kansas City here in the United States so  
that she can receive medical care that she is not able to obtain  
where she lives.

Doa'a suffers from several medical maladies: arthrogyrposis since birth, with muscle contraction and abnormal gait and back deformity that's caused by Rt. scolios.

And Doa'a needs to receive some highly specialized medical treatment so that she can live as normal of a life as she possibly can. But unfortunately, she's not able to receive the specialized medical care she needs to have where she is living in the war-torn Gaza Strip of Palestine.

I had the privilege of helping bring Doa'a to the Kansas City for medical treatment when she was not yet two years old, and I was working in the office of (at the time) US Representative Dennis Moore (KS-03). And Doa'a recently reached out to me on Facebook and asked me to help bring her back to Kansas City so that she can receive more medical treatments.

Now I am in the process of establishing this charity, Joe's Cowtown Foundation, so that I can help bring Doa'a here to the US so that she can receive medical care. As well as to help out lots of kids around the world who are not able to receive the medical treatment they need where they live.

Additionally, through this charity, I will be providing students with lots of youth empowerment opportunities, including the chance to help raise funds and increase awareness for Doa'a and lots of kids like her around the world.

Through these efforts, I believe that we will be able to help create a better world for us all. And that we will be able to help alleviate the suffering of wonderful people like Doa'a Al-Dalou.

Thanks very much for considering to expedite the processing of our 1023 application! Receiving our 501c3 tax-exempt status as quickly possible would greatly enhance our ability to raise money for Doa'a. And it would also help us obtain the permission we need to have from the US government so that we can bring Doa'a to Kansas City in the US and help her receive the medical care she really needs to have.

And I really do appreciate any help we may be able to receive from you all to that end. As does Doa'a and her family!
