Official Rules – Comfort for a Cause Raffle

A Raffle to Benefit the Farmington 500 Sports Scholarship Fund

1. Organizer

This raffle is organized and operated by Aesthetic HVAC, LLC, a New Hampshire limited liability company located at 350 Route 108, Unit 2A, Somersworth, NH 03878, in partnership with C&C Electric, LLC, Mitsubishi Electric, and Homans Associates (collectively, "Partners"). Aesthetic HVAC, LLC is responsible for raffle administration, including ticket sales, drawing, and prize fulfillment.

2. Eligibility

- Entrants must be 18 years of age or older at the time of ticket purchase.
- The installation site must be located within a 30-mile radius of Farmington, NH (ZIP code 03835).
- Eligible installation sites include residential homes, small businesses, and nonprofit organizations.
- Residential winners must be the legal homeowner or provide a notarized letter of permission from the homeowner authorizing installation.
- Small businesses must operate in a commercial or mixed-use space and provide documentation of ownership or landlord approval for installation.
- Nonprofit organizations must operate from a property that meets technical and safety requirements and provide proof of nonprofit status (e.g., 501(c)(3) letter).
- Tickets may be purchased on behalf of eligible individuals or organizations, but the name on the winning ticket must match the eligible party receiving the prize.
- Employees and immediate family members of Aesthetic HVAC, LLC, C&C Electric, LLC, Mitsubishi Electric, or Homans Associates are eligible to purchase tickets but are not eligible to win.
- Entrants must comply with all applicable laws. Void where prohibited.

3. Prize Details

- Electrical hookup by C&C Electric, LLC.

Prize Value: Approximate retail value is \$10,000–\$15,000, depending on installation specifics.

4. Ticket Purchase Information

- \$20 (10 Tickets), \$50 (40 Tickets), or \$100 (100 Tickets)
- No purchase limit.
- Available online.
- Payment accepted: credit/debit
- Each ticket has a unique number. Online purchases receive email confirmations.
- All sales are final unless otherwise required by law.

5. Raffle Drawing and Winner Notification

- Ticket sales: June 15 July 31, 2025.
- Drawing: August 2, 2025.
- Random selection method with impartial witness.
- Publicly announced via Facebook/Instagram within 24 hours.
- Winner will be contacted within 48 hours of drawing.
- Winner must confirm within 7 days or an alternate will be drawn.
- Proof of eligibility required.

6. Terms of Prize Acceptance

- Prize is non-transferable and not redeemable for cash. Tickets may be purchased on behalf of eligible individuals or organizations, but the name on the winning ticket must match the eligible party receiving the prize.
- Installation must be completed within 90 days of winner confirmation.
- Winner is responsible for any upgrades, customizations, or work beyond standard installation.
- By accepting the prize, the winner grants permission for promotional use of name, likeness, and system photos.
- Winner is responsible for all applicable taxes.
- Installation site must meet technical and safety requirements or winner forfeits prize.

Installation Limitations and Additional Costs:

- Standard installation includes a maximum of 50 feet of line set. Extra distance will be billed at standard rates.
- Installation assumes 1 or 2 story exterior wall with clear access. Extra fees apply for obstructions.
- Excludes ductwork, patching, painting, permitting, trenching, landscaping, or construction.
- Adequate electrical service is required. Panel upgrades or corrections are the winner's responsibility.
- Aesthetic HVAC, LLC and C&C Electric, LLC may decline installation for safety or code violation reasons.
