HEALTH REQUIREMENTS

- Client must provide proof of current Rabies, Distemper/Parvo & Bordetella vaccinations 7 days before drop-off.
- Client must communicate any health, behavioral, or dietary needs prior to boarding.
- Client is responsible for any veterinary care, medications, and related costs.
- Client is responsible for providing the dog’s food unless otherwise agreed upon.
- Female dogs in heat must be disclosed prior to arrival. STTP reserves the right to refuse boarding for females in heat.

VETERINARY EMERGENCY AUTHORIZATION

In the event of illness, injury, or emergency, STTP Kennels is authorized to seek veterinary treatment for the dog at the owner’s expense if the owner cannot be reached promptly.

CLIENT RESPONSIBILITIES

- Drop-off and pick-up must be at scheduled times. Dogs left beyond scheduled pick-up will incur an additional \$100/day boarding fee.
 - If the client cancels after booking, the deposit is forfeited.
 - Client agrees to disclose any history of aggression, biting, anxiety, or dangerous behavior prior to boarding.
- STTP Kennels reserves the right to refuse or discontinue boarding for dogs displaying unsafe behavior.

LIABILITY & INDEMNIFICATION

- Client acknowledges boarding involves inherent risks, including injury, illness, escape, or loss. Client accepts full responsibility for these risks and agrees to release, indemnify, and hold harmless STTP Kennels, its owner(s), and agents from all claims, costs, or damages, except in cases of proven gross negligence or willful misconduct.
- STTP Kennels is not responsible for lost or damaged personal items left with the dog, including beds, collars, leashes, bowls, or toys.
