## TRAINING SERVICES PROVIDED

STTP Kennels will provide professional bird hunting training, including:

- Obedience work, gun exposure, bird introduction, and field work.
- Use of live birds (additional cost, see below).
- All training sessions are one-hour, on-site sessions and include guidance on continuing training and reinforcement at home.

## TRAINING OPTIONS & COSTS

**BIRD PRICING** (subject to market changes):

Bird usage varies by dog, training goals, and progression. Bird costs will vary based on the number and type of birds used during each training session.

Training sessions canceled with less than 24 hours notice may be forfeited or subject to a rescheduling fee.

*If the trainer must cancel due to unforeseen circumstances, the deposit will be refunded or applied to a rescheduled date.*

## **HEALTH REQUIREMENTS**

- Client must provide proof of current Rabies, Distemper/Parvo & Bordetella vaccinations.
- Client must communicate any health, behavioral, or dietary needs prior to training.
- Client is responsible for any veterinary care, medications, and related costs.
- Female dogs in heat must be disclosed prior to arrival. STTP Kennels reserves the right to reschedule or refuse training for females in heat.

## **VETERINARY EMERGENCY AUTHORIZATION**

In the event of illness, injury, or emergency, STTP Kennels is authorized to seek veterinary treatment for the dog at the owner's expense if the owner cannot be reached promptly.

## **CLIENT RESPONSIBILITIES**

- If the client cancels training after booking, the deposit is forfeited.
- Client agrees to disclose any history of aggression, biting, anxiety, or dangerous behavior prior to training.
- STTP Kennels reserves the right to refuse or discontinue training for dogs displaying unsafe behavior.

## **LIABILITY & INDEMNIFICATION**

- Client acknowledges training involves inherent risks, including injury, illness, or loss.
- Client accepts full responsibility for these risks and agrees to release, indemnify, and hold harmless STTP Kennels, its owner(s), and agents from all claims, costs, or damages, except in cases of proven gross negligence or willful misconduct.
- Client grants permission for STTP Kennels to photograph and/or video the dog for training, promotional, and social media purposes.
- Client acknowledges and authorizes the use of approved electronic training collars as part of the training process when deemed appropriate by the trainer.
- Client understands that all dogs learn differently and that no specific training outcome, level of performance, or timeline can be guaranteed.
