SERGEANT-AT-ARMS POSITION CREATED

By Order of Board of Directors (BOD)

At the November 12, 2023 BOD meeting President Gene Preston explained to the board his desire to have a Sergeant-At-Arms position created and an individual appointed. Most organizations have a sergeant-at-arms mostly to assist the president at meetings.
