Did you know Donald Trump is a malignant narcissist?



Dr. John Gartner, a clinical psychologist and former professor at Johns Hopkins Medical School, has repeatedly and publically described Donald Trump as a “malignant narcissist.”

Dr. Gartner argues that Trump is both evil and demented and exhibits the four core traits of malignant narcissism. Adolf Hitler exhibited the same traits. They include:

- 1. Narcissism-** Extreme grandiosity of one’s self.
- 2. Anti-social disorder-** A long-term pattern of lying, manipulating, exploiting, or violating the rights of others. People with this disorder often lack empathy or remorse, frequently struggle with the law, and may act recklessly, aggressively, or deceitfully to get what they want.
- 3. Paranoia-**Delusions of persecution and a belief that adversaries are constantly attacking.
- 4. Sadism-**The tendency to derive pleasure from the pain or suffering of others.

Duty to Warn

In 2017, Dr. Gartner founded the duty to warn movement (organization) which circulated petitions signed by tens of thousands of mental health professionals. The group has argued that they have an ethical obligation to warn the public about what they perceive as Trump’s psychological unfitness for the presidency.

In a recent commentary, Gartner has expanded his analysis, claiming that Trump’s psychological state is worsening. He has stated that Donald Trump exhibits classic signs of frontal lobe dementia. He bases this assessment on behavioral observations rather than a clinical examination, pointing to several indicators.

Gartner claims that Trump “no longer has the frontal lobe” to inhibit impulsive outburst or regulate his judgment, as evidenced by erratic late- night postings and sudden shifts in policy or meetings. He has pointed to a decline in

Trump's coherent speech patterns, difficulty finishing sentences, and the frequent use of repetitive phrasing. The doctor compares Trump's dementia to a rock rolling down hill.

Mary Trump's Speaks

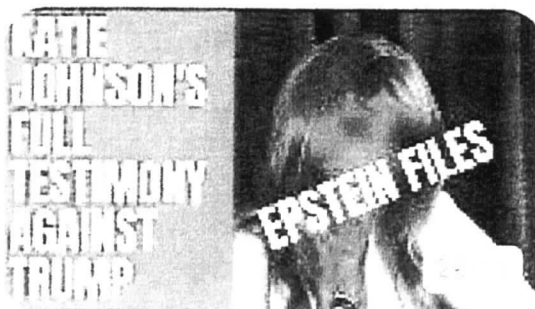
Mary Trump, a clinical psychologist and the niece of Donald Trump, extensively diagnosed her uncle with malignant narcissism. She detailed these claims in her 2020 memoir, *"Too Much and Never Enough: How My Family Created the World's Most Dangerous Man."*

In her book and subsequent interviews Mary Trump blames her uncle's behavioral patterns to the dysfunctional family environment that he grew up in.

Mary Trump attributes Trump's psychological issues to the profound emotional abuse he suffered under the patriarch of the family, Fred Trump (Donald's dad).

Mary Trump's psychological assertions were the source of deep divisions within the family. Her uncle Robert Trump, unsuccessfully attempted to use the courts to block the publication of the tell-all memoir. Of course, the White has dismissed her accusations as a collection of falsehoods written for financial gain.

WHAT HAPPENED TO KATIE?



The following is the full complaint of Katie Johnson (Jane Doe) who filed a lawsuit in 2016 in the State of New York claiming she was sexually abused and even raped by Donald Trump and Jeffery Epstein when she was 13-years old. Tiffany Doe (Epstein's ex-employee) witnessed these crimes against Katie and a 12-year old Hispanic girl named Maria. All three females are missing today. Even Katie's attorney (Lisa Bloom) has no idea where she is.

1. I am a competent adult over 18 years of age able to testify as to personal knowledge. The facts in this declaration are true and correct to the best of my knowledge, information, and belief, and I am competent to testify to them if called upon to do so.
2. I was subject to extreme sexual and physical abuse by the Defendants, including forcible rape, that took place at several parties of Defendant Epstein during the summer of 1994 in New York City at a residence used by Defendant Epstein. During this period, I was 13 years old.
3. More particularly, I traveled by bus to New York City in June 1994 in the hope of starting a modeling career. I went to several modeling agencies but was told that I needed to put together a modeling portfolio before I would be considered. I then went to the Port Authority in New York City to start to make my way back home. There I met a woman who introduced herself to me as Tiffany. She told me about the parties and said that, If I would join her at the parties, I would be introduced to people who could get me into the modeling profession. Tiffany also told me I would be paid for attending.
4. The parties were held at a New York City residence that was being used by Defendant Jeffery Epstein. Each of the parties had other minor females and a number of guests of Mr. Epstein, including Defendant Donald Trump at four of the parties I attended. I understand that both Mr. Trump and Mr. Epstein knew that I was 13 years old.
5. Defendant Trump had sexual contact with me at four different parties in the summer of 1994. On the fourth and final sexual encounter with Defendant Trump, Defendant Trump tied me to a bed, exposed himself to me, and then proceeded to forcibly rape me. During the course of this savage sexual attack, I loudly pleaded with Defendant Trump to stop but did not. Defendant Trump responded to my pleas by violently striking me in the face with his open hand

and screaming that that he would do whatever he wanted.

6. Immediately following this rape, Defendant Trump threatened me that, were I ever to reveal any of the details of Defendant Trump's sexual and physical abuse of me, my family and I would be physically harmed if not killed.

7. Defendant Epstein had sexual contact with me at two of the parties that summer. On the second occasion involving Defendant Epstein, Defendant Epstein forced himself upon me and proceeded to rape me anally and vaginally despite my loud pleas to stop. Defendant Epstein then attempted to strike me about the head with his closed fists while he angrily screamed at me that he, Defendant Epstein, should have been the one who took my virginity, not Defendant Trump, before I finally managed to break away from Defendant Epstein.

8. Immediately following this rape, just like Defendant Trump, Defendant Epstein threatened me not to ever reveal any of the details of Defendant Epstein's sexual and physical abuse of me or else my family and I would be physically harmed if not killed.

What Happened to Maria

9. Both Defendants had let me know that each was a very wealthy, powerful man and indicated that they had the power, ability and means to carry out their threat. Indeed, Defendant Trump stated that I shouldn't ever say anything if I didn't want to DISAPPEAR like Maria (12-year old Hispanic female) that was forced to be involved in the third incident (lesbian act) with Defendant Trump and I had not seen since that third incident, and that he was capable of having my whole family killed.

10. The duress imposed on me by Defendants not to ever reveal any of the details of the sexual and physical abuse caused to me by Defendants has not terminated and the fear it is instilled in me has not subsided. Unfortunately, making matters worse for me, I was subjected to daily painful reminders of the horrific acts of Defendant Trump via mass media coverage of him starting last summer that, over a short period of time, became continuous and unavoidable.

11. The duress had prevented me from starting litigation before this year. However, as soon as I surfaced, I received threats. More specifically, shortly after my first complaint was filed in California on April 26, 2016, I started receiving threatening phone calls on a cell phone that I owned. The calls were never more that 20 seconds or so before they hung up and they were always from a blocked or unavailable phone number according to my caller ID feature. Since I changed phone numbers, the threatening calls have completely stopped.

12. This litigation involves matters that are highly sensitive and of a personal nature, and I believe that identification of me would pose a risk of retaliatory physical harm to me and to others.

13. I have no reason to believe that the Defendant's threats have ever been lifted or will ever be lifted and so I request that the Court issue an order protecting me and my family from harm and harassment by the Defendants.





Editor's note: The following information below came from the book American Kompromat by journalist Craig Unger. The book was published in 2021. In the book, Yuri Shvets a former KGB agent claims Donald Trump was cultivated and placed in the White House by Communist powers working out of Moscow:

Donald Trump was cultivated as a Russian asset over 40 years and proved so willing to parrot anti-western propaganda that there were celebrations in Moscow, a former KGB spy has told the Guardian.

Yuri Shvets, posted to Washington by the Soviet Union in the 1980s, compares the former US president to "the Cambridge five", the British spy ring that passed secrets to Moscow during the second world war and early cold war.

Now 67, Shvets is a key source for American Kompromat, a book published by journalist Craig Unger, whose previous works include House of Trump, House of Putin. **The book also explores the former president's relationship with the disgraced financier Jeffery Epstein.**

"This is an example where people were recruited when they were just students and then they rose to important positions; something like that was happening with Trump," Shvets said by phone from his home in Virginia.

Shvets, a KGB major, had a cover job as a correspondent in Washington for the Russian news agency Tass during the 1980s. He moved to the US permanently in 1993 and gained American citizenship. He works as a corporate security investigator and was a partner of Alexander Litvinenko, who was assassinated in London in 2006.

Trump Appears on Russian Radar

Unger describes how Trump first appeared on the Russians' radar in 1977 when he married his first wife, Ivana Zelnickova, a Czech model. Trump became the target of a spying operation overseen by Czechoslovakia's intelligence service in cooperation with the KGB.

Three years later Trump opened his first big property development, the Grand Hyatt New York hotel near Grand Central station. Trump bought 200 television sets for the hotel from Semyon Kislin, a Soviet emigre who co-owned Joy-Lud electronics on Fifth Avenue.

According to Shvets, Joy-Lud was controlled by the KGB and Kislin worked as a so-called "spotter agent" who identified Trump, a young businessman on the rise, as a potential asset. Kislin denies that he had a relationship with the KGB.

Then, in 1987, Trump and Ivana visited Moscow and St. Petersburg for the first time. Shvets said he was fed KGB talking points and flattered by KGB operatives who floated the idea that he should go into politics. The ex-major recalled: "For the KGB, it was a charm offensive. They had collected a lot of information on his personality so they knew who he was personally. The feeling was that he was extremely vulnerable intellectually, and psychologically, and he was prone to flattery.

This is what they exploited. They played the game as if they were immensely impressed by his personality and believed this is the guy who should be president of the United States one day: it is people like him who can change the world. They fed him these so-called active measures sound bites and it happened. So it was a big achievement for the KGB active measures at the time."

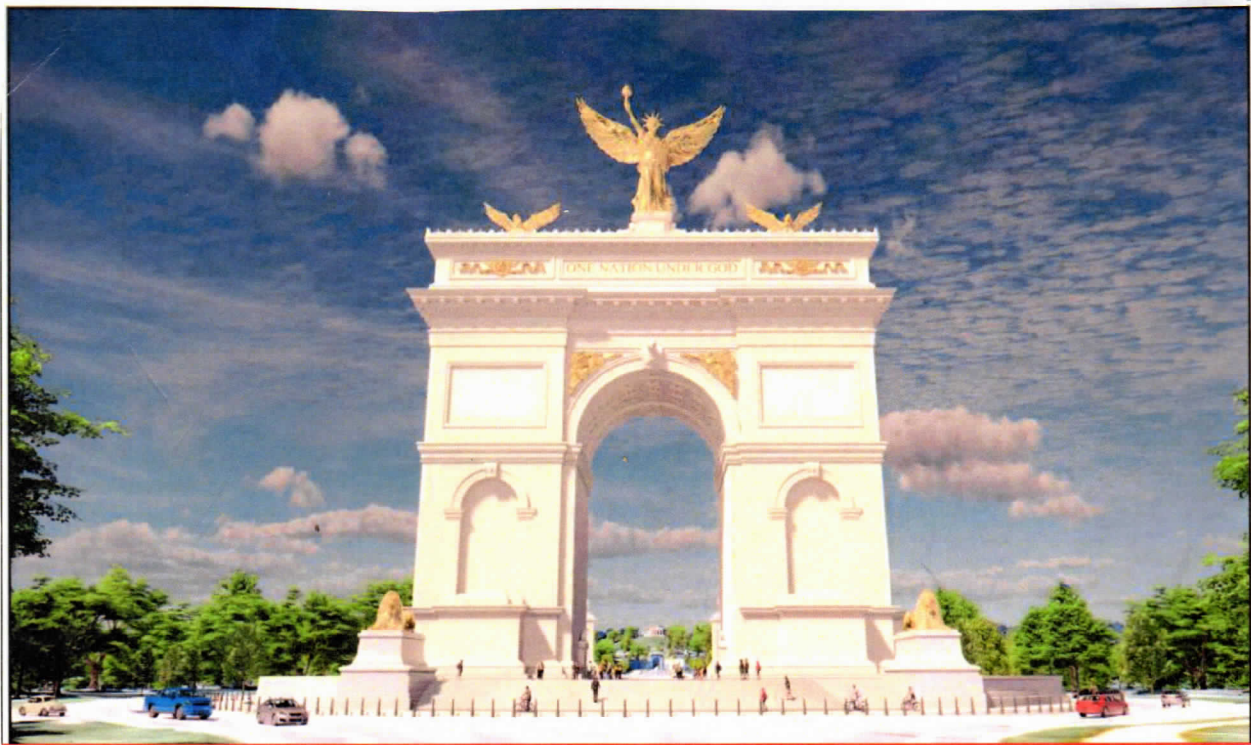
