CANCELLATION AND REFUND POLICY:

If an applicant is denied admission by the school, the applicant is entitled to a refund of all monies paid.

Three-Day Cancellation: An applicant who provides written notice of cancellation within three days of signing an enrollment agreement is entitled to a refund of all monies paid (less \$200 non-refundable application and materials fees). Refund to be paid no later than 45-days after written notice of cancellation.

Other Cancellations: An applicant requesting cancellation more than three days after signing an enrollment agreement and making an initial payment may reschedule for a future training within a one year period from the original training date **but will not receive a refund.**
