

# Terms and Conditions

**Updated 25.2.21** 

In order to keep everyone safe at Forest School I would like you to be aware of and agree to the following:

- If you are taking part in Forest School please wear the clothes that are on the recommended <u>Personal Protective Clothing</u>. This will avoid stings, scratches, ticks, kneeling on wet ground.
- It is recommended that you use insect repellent and sun cream at the appropriate time of year.
- You are required to disclose any medical needs/allergies or food intolerances during the online booking procedure. This is so we can cater appropriately and also use first aid appropriately if needed.
   ALL INFORMATION IS KEPT CONFIDENTIAL.
- You are required to disclose any additional needs that may affect your child's behaviour at Forest School. This is more relevant when you are not accompanying your child so we can prepare appropriately.
- If children want to bring their own tools they must let one of the members of staff know.
- Children need to be independent with the toilet and changing their own clothes if required. If there is any chance that your child will need help please let staff know and we can plan for this together in order to meet Safegaurding requirements.

### • Refunds - GRMB will give a full refund if:

The session is cancelled due to high winds or lightening
The session is cancelled by us for any other reason
If someone in your household develops symptoms of Corona Virus
and you need to self isolate.

If a child is asked to leave Forest School due to inappropriate behaviour that risks the safety of others (see behaviour policy) the remaining days that are booked will be refunded.

### • GRMB will not give a refund if:

If you do not give 24 hours notice of cancelling a session

### Covid 19 current guidance - What is different?

- If any member of your household develops <u>symptoms of Corona</u> <u>Virus</u> you must notify before the session you must notify me on the number below as soon as possible.
- Holiday Clubs will be run in bubbles of children as per current <u>Gov</u> <u>guidelines</u> at the time.
- You are unable to transfer your ticket to another child.

- Your child and anyone else who is attending the session must be fit and well on the day.
- If your child or anyone in your household has symptoms then you are required self isolate as per current Government guidance.
- If your child develops symptoms during a session where they are unaccompanied bean adult we will call the contact number you have given and you will be required to collect your child as soon as possible.
- Your child will be looked after outside of basecamp by an adult wearing appropriate PPE (personal protective equipment)
- If a child or member of staff test positive for Covid-19 ALL of their social bubble must follow current Government guidance. Tests are now available for everyone.
- The toilet will be cleaned regularly.
- There will be a hand washing station for open access and hand sanitiser outside the toilet.
- If you are dropping your child at Forest School, please could you adopt the stop, drop and go method. An adult will be available to greet your child and help them settle in to camp. There is no need for additional adults (not in the bubble) to come into camp.
- The same process will be applied for collection. Children will have their bags ready and will be directed to you.

## **Safeguarding information**



All staff are DBS checked and have experience working in the outdoors and activities are fully risk assessed. Staff are trained in paediatric outdoor first aid. We are fully insured for all activities. The site has clear boundaries and is secure. Please read GRMB policies and procedures in The Forest School Handbook for more information.

- It will be the accompanying adult's responsibility to support their child to maintain social distances rules. Children and adults will be required to wash their hands at key points during the session. These include entering, exiting and before and after eating. Warm water, soap and hand gel are available to use.
- Some activities may include the use of tools. Children five and under may need the support of their accompanying adult. Tools will be cleaned between each use unless we are working in a planned bubble of children (Holiday Clubs)
- Where the use of a protective glove is required, antibacterial hand gel should be used before and after use.
- Some activities may have been withdrawn or amended to adhere to Government Guidelines. We are unable to offer hammock play and make your own pizza during this time.
- Campfire food will be prepared before and brought into Forest School.
