## **RELEASE AND WAIVER OF LIABILITY - MEMBER**

In consideration of being permitted to benefit from use of the premises, facilities and services, leased by the Wild Rose Hunting Retriever Club located at W4;27;26;18;NW, and W4;27;26;18;E, and municipally described as Township 262, Kathryn, Alberta T0M 1E0 (the "Club's Property").

I, \_\_\_\_\_, for myself, my heirs, administrators and assigns, do hereby **REMISE, RELEASE AND FOREVER DISCHARGE** Wild Rose Hunting Retriever Club and its directors, officers, employees, and agents and their respective successors and assigns, whether any such be past or present (hereinafter collectively referred to as the "Club"), of and from each and every manner or description of actions, causes of action, debts, claims, counterclaims, demands, damages, liabilities, obligations, costs or expenses, known or unknown, which I ever had, now have, or may have in the future arising from any and all possible incidents of personal injury and/or property loss or damage as a result of my presence at and use of the Club's Property.

I, \_\_\_\_\_, hereby sign this agreement on behalf of myself, my personal representatives, agents, heirs or assigns.

### **FOR MYSELF, MY HEIRS, ADMINISTRATORS AND ASSIGNS HEREBY ACKNOWLEDGE THAT:**

- 1) I understand that this Release and Waiver of Liability discharges the Club from any liability or claim that I may have against the Club with respect to any personal injury and/or damage, destruction, or financial loss to personal property that may result from my use of the Club's Property.
- 2) I am voluntarily participating in the activities offered by the Club, which may include but are not limited to:
  - a. dog training my own dog(s) and helping others train their dog(s), including walking or running my and/or their dog(s), having my and/or their dog(s) play with my and/or other members' dog(s);
  - b. helping put on the Club's dog competitive and training events (registration, gunning (throwing birds and using starter pistols or also using wingers or bird launchers), marshalling the dog(s) and handles);
  - c. land maintenance, clean-up and repairs (mowing the grass with riding mower or gas mowers, weed whacking, using other gas fuelled equipment shovelling, lifting and carrying heavy items (wood or buckets of dirt/sand), fence repairs, building wooden pallet blinds, lifting and moving hay bales);
  - d. providing paid-for or donated service work.

(the "Activities").
- 3) I understand that these Activities have inherent risks which cannot be eliminated regardless of the care taken to avoid them and include but are not limited to:
  - a. injury or death from the use of the dog training equipment;
  - b. injury or death from interactions with any dog(s) on the Club's Property;
  - c. injury or death from stepping into gopher holes or tripping over equipment;
  - d. injury or death from falling onto wire fencing or other structures used for training on the property;
  - e. injury or death from vehicles driving on the property or being parked on the property;
  - f. injury or death from falling into the water canal located on the east side of the Club's Property;
  - g. injury or death from falling off the footbridge that runs across the water canal located on the

Club's Property;

- h. injury or death from the use or another's use of maintenance equipment;
- i. injury or death from choking on food provided by the Club at events;
- j. injury or death from the use of Club BBQ and utensils;
- k. injury or death from setting up of various Club equipment including bird dryers, bird launchers, wingers, starter pistols etc.;
- l. injury or death from erecting Club tents and tables;
- m. injury or death from the use of the Club's transportation trailer;
- n. injury or death from the use of the porta potty located on Club Property;
- o. injury or death resulting from the opening or closing of the entrance gate to Club Property;
- p. injury or death from the use of roads and vehicle paths located on Club Property;
- q. injury or death from directing parking at Club events;
- r. injury or death from stepping into or falling in the ponds, culverts and/or bodies of water located on the Club's Property.

(the "Risks and Dangers")

- 4) I understand that the Club will not assume any responsibility for the security or general wellbeing of my personal property.
- 5) I acknowledge that my participation in the Activities is entirely voluntary and that the Activities are not supervised;
- 6) I fully understand the inherent Risks and Dangers associated with my use and participation in Activities on the Property and accept same entirely at my own risk;
- 7) I fully understand the inherent Risks and Dangers associated with allowing my children or accompanied minors to use and participate in Activities on the Property and accept same entirely at their own risk;
- 8) I acknowledge that at no time whatsoever will a child or minor be permitted on Club Property and/or participate in Activities on the Property without being accompanied by an adult and/or Parent/Guardian.
- 9) I acknowledge that the Club's Property is in a natural, non-urban setting and therefore an encounter with any wild animal during my use of the Club's Property is possible and further that suffering serious injury or death from a wild animal encounter is also a possibility as a result of my use of the Property;
- 10) I acknowledge that my use of the footbridge over the Western Irrigation District canal is done so at my own risk.
- 11) I expressly agree that this Release and Waiver of Liability is intended to be as broad and inclusive as permitted by the laws of the Province of Alberta and that this Release and Waiver of Liability shall be governed by and interpreted in accordance with the laws of the Province of Alberta. I agree that if any clause or provision of this Release and Waiver of Liability shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release and Waiver of Liability which shall continue to be enforceable.
- 12) I shall defend, indemnify and hold harmless the Club from all losses, claims, expenses and demand,

including legal fees, that may be incurred by the Club, that are related, directly or indirectly, to my use or participation in the Activities at the Club's Property.

13) I agree that if I bring a guest to the Club's Property and the guest brings any action against the Club that I shall defend, indemnify and hold harmless the Club from all losses, claims, expenses and demand, including legal fees, that may be incurred by the Club, that are related, directly or indirectly, to my guest's use or participation in the Activities at the Club's Property.

14) I agree that if I bring a child or accompanied minor to the Club's Property and an action against the Club is brought by a litigation representative of that child or accompanied minor, I shall defend, indemnify and hold harmless the Club from all losses, claims, expenses and demand, including legal fees, that may be incurred by the Club, that are related, directly or indirectly, to the child's or accompanied minor's use or participation in the Activities at the Club's Property.

15) I agree not to bring or maintain any court proceedings which may enforce or claim or tend to enforce or claim any debt, claim, causes of action or proceeding of a type hereby released nor to permit any person to bring or maintain any such court proceedings in my name. I further agree not to make any claim or take any proceeding in respect of any matter contemplated by this Release and Waiver of Liability against any person or corporation who might claim contribution or indemnity from the Club.
