ADVERTISEMENT: Assistant Professor Post (Temporary/Contractual)

Applications are invited for Assistant Professor on temporary (Contractual) basis through Divisional selection board (DSB) at Rajmata Jijau Govt. Medical College, Buldhana.

The candidate is advised to carefully read all rules & regulations before filling application form.

Application forms will be available in Gazette Section of College on payment of Rs.200/- At Cash section of college. Application form should be submitted along with all required documents.

The Candidate is required to submit application form in-person (Candidate or anybody on behalf of Candidate) between **19/05/2026 to 29/05/2026**.

The application should be submitted to Miss Shewta Bairagi, Junior clerk in Gazetted section of college between 11:00 Am to 5:00 PM.

No application will be considered if institute receives application via post/email.

ELIGIBILITY: As per "NATIONAL MEDICAL COMMISSION (POSTGRADUATE MEDICAL EDUCATION BOARD) NOTIFICATION New Delhi, the 30th of June 2025 TEACHERS ELIGIBILITY QUALIFICATIONS IN MEDICAL INSTITUTIONS REGULATIONS, 2025"

Broad specialty:

- ✓ Candidate who has passed MD/MS/DNB in a recognized/permitted medical college in the concerned subject and

- (a) One year as Senior Resident in the concerned subject as specified in regulation 8 in a recognized medical institution.

Note 1 : The requirement of one-year Senior Resident experience is relaxed for those appointed directly as Assistant Professor in Government medical institute immediately before the publication of these regulations.

Note 2 : The experience gained by a Demonstrator in a medical institution of his specialty having a postgraduate degree, shall be considered equivalent to the experience required as a Senior Resident for the purpose of eligibility for the post of Assistant Professor.

Note 3 : The experience gained by a Demonstrator in a medical institution of his specialty having a Master of Science and Doctor of Philosophy degree shall be considered equivalent to the experience required as a Senior Resident of the purpose of eligibility of the post of Assistant professor Or

- (b) Specialist Medical officers of the Armed Forces having at least one year teaching experience or two years of clinical experience after obtaining the requisite postgraduate qualification in the concerned subject.

Note : In the specialty of Aviation Medicine and Marine Medicine two years of such experience in flying squadrons and in Diving and Escape training Schools respectively will be considered equivalent to one year of teaching experience (in Lieu of Senior Resident) to become an Assistant Professor; Or

(C) a non-teaching Consultant or Specialist or Medical Officer, possessing postgraduate medical degree with at least two years of experience in a Government hospital having at least 220 beds shall be eligible to become an Assistant Professor of that broad specialty without the requirement of experience as Senior Resident and shall complete the Basic Course in Biomedical Research within two years of appointment; or

(d) diploma holders appointed as Senior Resident in a recognized medical institution before 08.06.2017 having total experience of four years as Senior Resident; or

(e) diploma holders working as Specialist or Medical Officer in the respective departments of a government medical institutions or Government medical institution running National Board of Examination and Medical Science recognized teaching programmed having cumulative experience of Six years.

Note : For the purposes of appointment as faculty in Emergency Medicine department, the previous teaching experience in the broad specialties of General Surgery or Anesthesia or Respiratory Medicine or Orthopedics or General Medicine shall be counted and on such appointment, shall complete faculty development programmed or trainings prescribed by the Commission within two years of appointment.

- ✓ In case of DNB candidate equated to MD/MS in terms of clause 4A of Schedule-I, in addition to 3- year teaching experience in the subject as Resident/ Registrar/ Demonstrator/ Tutor/ or work experience gained during DNB training, one year as Senior Resident in the concerned subject in a recognized/permitted medical college. **The candidate shall also fulfill the DNB equivalence qualification criteria as per Rule.No.6**
- ✓ Candidate must have permanent registration of MCI/MMC with recent renewal.

RULES & SELECTION PROCESS (before filling application forms read rules carefully):

1. Candidate must have passed required qualification and eligible as per the NMC TEQ Dated 14-2-2022 for Assistant Professor Appointments.
2. The temporary/Contractual selection will be of 364 Days only. In case the Commissioner office/DMER undertakes central DSB then services will be terminated of all selected candidates without any prior notice.
3. Application should be submitted in the given format only. Candidate should verify the submitted information in application form. In case of wrong / false information submitted by the student and if brought to the notice by other candidates, the application is liable for rejection, and he/she will be facing legal consequences also.
4. Candidates should fill the application form in the given format only in **his/her own handwriting. Prepare "one PDF" Scan copy of application all required documents.**
5. Maximum age limit for appointment will be: Open: 38 years & Reservation: 43 years

6. **Determination of equivalence of the qualification of DNB (Broad Specialties) with MD/MS.** (Ref No. MCI-12(2)/2018-Med.Misc./142810. Dated 31-10-2018.... In the "Minimum Qualifications for Teachers in Medical Institutions Regulations, 1998", in Schedule – I, the following clause shall be added after Sl. No. 4 :- **"4A. Determination of equivalence of the qualification of DNB (Broad Specialities) with MD/MS & DNB (Super-Specialities) with DM/M.Ch.)**

- a) Those candidates who have undergone DNB training in an institution which now runs MCI recognized postgraduate degree courses in a given subject, their DNB qualifications shall be considered at par with MCI recognized qualifications in that subject only.
- b) Those candidates who have undergone DNB training in a multi-specialty teaching hospital with at least 500 beds, involved in various postgraduate teaching programmes provided that the one out of three DNB supervisors (teachers) qualify as postgraduate teacher as per MCI norms in his/her

previous appointment; and one out of remaining two should qualify as postgraduate teacher as per MCI regulations with the following bed requirement for teaching unit: Postgraduate Broad Specialties 30 beds per unit & 50% beds should be teaching beds. Such a qualification shall be considered at par with MCI recognized qualification.

- c) Those candidates who have three years teaching experience in the subject as Resident/Registrar/ Demonstrator/ Tutor / or work experience gained during DNB training in Broad Specialities course in other locations/institutions (100 or more bedded hospitals) shall work for one additional year as a senior resident in a MCI recognized/permitted institution for equivalence with MD/MS
- d) Those candidates who have three years teaching experience in the subject as Resident/Registrar/ Demonstrator/ Tutor / or work experience gained during DNB training or after possessing DNB qualification, in both Broad Specialities course from an institution not covered in sub-clauses (a) to (c) shall work for two additional years as Sr. Resident/Research Associate (CSIR) in a MCI recognized /permitted medical college/institution for equivalence with MD/MS

Note: All DNB Students should submit official certificates from DNB Institute mentioning details of Bed strength information (how many bedded hospital) and MCI recognition certificate of institute. The candidate as per above clauses, if applicable, should submit SR experience in an MCI recognized/permitted institution. After submission of these documents ONLY the candidate will be considered equivalent to MD/MS for preparing provisional merit list.

7. For each attempt in MD/MS/DM/Mch/DNB exams 2 marks will be deducted from the total marks of PG. Final corrected marks will be taken into consideration for preparing provisional merit list.

8. Selection Process:

- Candidate will be called for interview based on provisional candidates list.
- Candidates will be required to produce all original certificates for verification at the time of interview.
- Candidates will be allowed for interview based on Documents verification by the DSB committee /Scrutiny team. No documents will be allowed to be added after cut-off date of application submissions.
- Selection of candidate will be based on Marks obtained in the interview.
- Candidate must attend interview for selection process, failing which the claim stands cancelled. No other person on behalf of candidate will be allowed during interview.
- The preference of selection will be first to MD/MS candidates followed by DNB.
- In case of equal marks or tie in postgraduation filter will be age followed by percentage marks (%) (Minor + Major/ or III MBBS marks % as per old passing pattern of examination).
 - As DNB candidates has passing grades, Provisional merit list amongst DNB candidates will be according to percentage marks (%). Minor + Major/ or III MBBS marks % as per old passing pattern of examination. In case of equal marks or tie for DNB candidates, filter will be age for preparing the provisional merit list.

9. For Inter se rotation groups will be as below
- ✓ **Group-1:** SC, ST
 - ✓ **Group-2:** VJ, NT1(B),
 - ✓ **Group-3:** NT2(C), NT3(D), OBC/SEBC
- The seats remaining vacant from EWS category will be allotted to Open Category candidate.
10. Category students should produce Caste certificate, Caste validity & non-creamy layer certificate valid up to **31-3-2027**. If students are not producing these documents, they will be considered as Open category applicants. Kindly note acknowledgement receipts of submitted to competent authority issuing Validity/NCL proposals will NOT be considered for category claim. **Submission of such documents after last date will NOT be acceptable.**
11. Candidates claiming EWS should submit the EWS certificate of current financial year in the specified format by the Govt. (Annexure-A). Kindly note acknowledgement receipts of submitted to competent authority issuing certificate will NOT be considered. **Submission of such documents after last date will NOT be acceptable.**
12. Only **One Provisional Candidate list** will be displayed on the Rajmata Jijau Govt. Medical College, Buldhana college website (www.gmcbuldhana.com/) **College Notice Board**. All details as per the schedule will be notified on website only. Applicants are advised to check website as per the schedule.
13. Private practice of any kind is NOT permitted during the period of appointment.
14. **Disciplinary action will be taken if the concerned department HOD reports about absenteeism/ irregularity in the duties/Nuisance/any other complain as may be. The candidate is liable for termination without prior notice.**
15. The selected Assistant Professor will be required to undertake undergraduate and/or postgraduate teaching as per NMC curriculum, conduct lectures, practicals and tutorials, provide clinical teaching where applicable, participate in student assessment and examinations, engage in research and academic activities, perform patient care duties in clinical departments, maintain academic and departmental records, comply with NMC and institutional regulations, participate in faculty development programs, and carry out any other academic or administrative duties as assigned by the competent authority.
16. **Important to note that for any subjects if institute receives appointments through MEDD/ Direct recruitment through selection board/MPSC/transfer,etc, the candidate services will be terminated without any notice.**
17. **POLICY FOR TERMINATION OF SERVICES:** Once candidate is posted by MEDD/MPSC/Transfers the DSB selected candidates from this institute will be terminated by following rules without any notice:
- a. The termination will be as per the provisional selection list of this advertisement.
 - b. After DSB interview and as per the requirements & recommendations of HODs, if posts are remaining vacant and new orders are issued on vacant posts, then all such candidates will be placed in continuation of last DSB selected candidates in the respective department list as junior most irrespective of marks obtained in the specialty subject.
 - c. For termination of services the junior most will be terminated first.

- d. The Category rotation/Inter se status will remain for all temporary appointments of this DSB. The same will be considered when an MPSC selected candidate comes for joining /permanent transfers and accordingly the temporary services will be terminated considering the selection category of candidate reporting for joining.
