





We would like to remind everyone of the "Charity Begins at Home" program. You make a charity quilt using your own fabric. The quilt is to be completed, including the quilting and binding, BEFORE turning it in. When you turn it in, we will put your name in a drawing for April. Yes, April is the deadline. The quilt does not have to be elaborate and can be any size.

The **Layette program** is also in April. We help the church with baby items and also quilts that are about 40" square. The baby items are onesies, socks, sleepers, diapers, receiving blankets, bibs, etc. The church wants **NEWBORN** sizes only. They assemble boxes of items in which to take a newborn baby home.

This month, we have **Charity Day** on **Saturday**, **Feb. 23rd**. We plan on doing pillowcases, grieving envelopes, and receiving blankets. Regular quilt kits will also be available. The church is supplying us with flannel to make the blankets. All project can be done on a regular machine but some would work better on a serger. If you have one, let us know if you plan on bringing it.

Blocks: (12) 3-1/2" strips cut into:

(83) 3-1/2" squares

(14) 3-1/2" x 9" rectangles

Borders:

(7) 2-1/2" strips

(7) 4" strips

MEDIUM - 1 YARD

(2) 4-1/2" strips cut into: (16) 4-1/2" squares

(4) 4" strips

DARK - 1 YARD

(2) 4-1/2" strips cut into (16) 4-1/2" squares

(4) 4" strips

BORDER - 1/2 YARD

(7) 2" strips

BINDING

(7) 3" strips



SUPPLIES



FOR A SCRAPPY QUILT:

Use 16 different Medium and 16 different Dark fabrics.

From **each** Medium and Dark fabric, cut:

- (1) 4-1/2" square
- (1) 4" x 14" strip cut into (4) triangles

1/4" foot, 6" Square-Up Ruler, 6" x 24" Ruler, Triangle in a Square Ruller, Marking Pen, Rotary cutter & Mat.

Lori Miller Lecture and Truck Show - January 2019 submitted by Jan Recinos

Former CAMEO member, Lori Miller met with us on January 17 to share stories about her life and her quilting journey. She has relocated to Oxford and says her husband is building her a new studio. She works at Decorative Stitch Quilt Shop and gives classes there. She brought 50 quilts to show, many of which were in the attic of her grandfather's house along with her grandmother's stash. The finished quilts and unfinished tops were varied and included applique, pieced work and traditional blocks. In most cases, the details of the making of the guilt was not known, but Lori has labeled them now for posterity. She continues to bring the stash out of the attic.

Lori's own cannon of work included her first clothing project, which was a plaid pair of pants and a matching top made when she was 9. She has created patterns herself in recent years and showed some of them in small, medium and large quilts. She advocates the software program Electric Quilt 8 and finds that it helps simplify patterns. If you look her up on the Decorative Stitch website, she tells 5 reasons that a computer design program can help with your quilting.

Lori has been published in many quilt magazines. She sent in pictures and they were accepted to her surprise. She said she had the goal of being published in every quilt magazine there is. She has also shown her quilts at Paducah and one has travelled for a year around the country.

Her workshop, the Clockwise Pillow, was unfortunately cancelled due to bad driving conditions. The new date is TBD.

Mary Lindquist -The Quilting Season

Mary Lindquist is a quilt shop owner in Saline Michigan. I had been hearing her name as a possible speaker for our Guild, so, I decided to go and talk to her about speaking to us about her



particular interest which is women and quilts. In January, I went with my friend Bonny to the Quilting Season and met Mary. She has a Block of the Month (BOM) group on Saturday mornings, and the discussion about the guilt block centered on her research about the life for American women in the 1780s. After the "Act for Solemnization of Marriages" was passed, people were to publish their intent to marry at three religious meetings separated by 3 days or over a 14 day period. During that time an objection to the marriage could take place. Mary read that when the marriage did go forward, it was not recorded in the histories as a ceremony or gathering of the families to celebrate. The couple seemed to continue to live in the same way they lived before the 'marriage' which surprised her.

What did change for the bride, however, was that she would begin to gather items for her own home and work on her own quilts. Other women would come and help and a quilt could be finished in three days. The groom may or may not stay with his wife in her family home, but after time, the length or reason not detailed, they would leave to go to their own home and that was called 'going to housekeeping'.

Mary researches this history and the BOM that the group works on reflects traditional blocks. She will be an interesting person to have give a talk to our guild, but she didn't want to set a date. I said I would ask her next year from time to time to see if she would be available. I encourage anyone in the Saline area to stop in to meet Mary Lindquist.

POSSIBLE FIELD TRIP TO THE HENRY FORD

The Henry Ford (THF) has a large guilt collection in its research department. In 2005, Fons and Porter published a book called Fons and Porter presents Quilts from the Henry Ford. It is 205 pages and contains history and quiltmakers' stories. There are 14 quilts by Susan McCord at THF. Susan McCord lived from 1825-1909 near McCordsville, Indiana. If you search her name on the internet, or in Pinterest, you will see some beautiful appliqued quilts. There are also 2 books about her guilts written in 2004 and 1988. In the Quilt Index, www. quiltindex.org, if you search: owner: The Henry Ford, you will see other quilts that are at the museum and not just from the McCord collection. Unfortunately, the photography of the quilts in the index do not do justice to the detail of the quilts. The blog in the Quilt Index has much clearer pictures.

On March 20, 2019, at 2:00 p.m., we have an appointment to meet with the curator of the collection at the Henry Ford. She will show us several quilts and tell us about their history. If you would like to go on the field trip, Jan Recinos must know by the February meeting, so that she can finalize the reservation. The cost of the field trip is a flat \$200 but the Board recommends that at least 15 people sign up in order for the guild to underwrite the cost. Sharon thanked the speaker. Reminded us to be thinking of people for the Nominating Committee and also if we would like to serve on the Board. Details of the responsibilities of each office is in the ByLaws and these are in the Membership Book or ask any questions of present Officers.

CAMEO Board Meeting January 24, 2019 Minutes

Meeting was held at the home of Darlene Baer. President Sharon Cratsenburg called the meeting to order at 7:15pm. Present were Kathy Debien, Jan Recinos, Lynda Draudt, Ann Bonnelli, Kathy Wilson, Judy Murray, Darlene Baer, Pat Baldauf, Cheryl Cawley and Barbara Lusk.

There were no corrections to the November minutes and they were approved, signed, dated and placed on file.

Retreat. Pat Baldauf reported that there are 43 people signed upfor the Retreat at Colombiere, April 11-14. They are compiling the information packet. Information was requested about a daily rate. That is possible but the Center charges a daily \$20 fee plus all meals. It works out almost the same as the overnight rates. People who signed up to come Thursday may check in any time after 2pm. Remember no meals are included until Friday lunch.

Charity Day. There was some confusion about the responsibility of a committee's liaison to the Board. She usually is not a member of the committee nor the chairperson, but makes sure the committee has chosen a chairperson and has met with all members of the committee. The liaison checks that the committee is meeting its requirements. This discussion sprung from the misplacement of the Charity Day sign-in sheet; there were 21 people signed up at one time during the Guild Meeting. Linda Wallace will be bringing the projects. Darlene Baer is a member of the Committee and liaison to the Board, so Darlene will become chair and call an organizational meeting. Pat will confirm that the budgeted amount for refreshments is \$200.

President. Sharon Cratsenburg has verified that we do not have to reregister our CAMEO Trademark until next year.

VP Membership. Lynda Draudt discussed plans for a New Members Tea and whether she should wait as we only had two new members. Members really valued the Tea and they suggested including charter members. Linda will work on it. Darlene mentioned that she no longer has a land line phone and Linda reported that she was about to update the Membership List and distribute it.

VP Facilitatior Cheryl Cawley. Lori Miller cancelled her workshop last Saturday due to the weather. There was difficulty notifying everyone. Lesson learned, there must be more than one person having the list of participants. Discussed rescheduling, will May work? The Church had been set up for us so the custodial staff still need to be paid however they will apply \$100 to a future rental. Three demos have been scheduled for the Whistle Stop: jelly roll rug, ribbon roses, bedazzle. Might be possible to arrange for scissor sharpening. Need to promote Mickey Depre's workshops in April, only 2 registrations so far.

VP Scheduler Jan Recinos Henry Ford Museum excursion to see the Susan McCord Quilt Collection is Wednesday, March 20 at 2pm. The cost is \$200, it was suggested that we should have at least 15 people signed up for the Guild to underwrite it.

Jan reported she had contacted speakers willing to set dates and fees for 2020. Members were concerned that just three programs were straining the budget so requested a spread sheet breakdown of all expenses. Workshop costs are covered by the registrants. Pat Baldauf will assist Jan with the spread sheet.

Assistant Treasurer Barb Lusk and Treasurer Pat Baldauf reviewed the financial books and all is well.

Corresponding Secretary Kathy Debien needs Lori Miller's address.
