### Declaration of Consent

A tattoo is a permanent change to my appearance and can only be removed by laser or surgical means, which can be disfiguring and/or costly. Additionally, it will not result in the restoration of my skin to its exact appearance previous to the tattoo application.

Tattoos can affect the way I am perceived and treated in the world. Although tattoos are becoming more popular, they are not necessarily welcome everywhere. Keep this in mind relating to your profession.

Tattoos will always be slightly different from the original drawing. Variances in skin type and tone may affect the way the tattoo is preserved/presented on my body. Additionally, the tattoo artist may need to adjust the design in shape, size, and color, if necessary. An accurate preview of the result can never be precisely simulated. Neither the artist nor the tattoo studio is responsible for the meaning or spelling of the symbol or text that I have provided to them. I also understand that over time, the colors and the clarity of my tattoo will fade due to unprotected exposure to the sun and the naturally occurring dispersion of pigment under the skin.

I fully understand that these risks, known and unknown, can lead to injury, including but not limited to infection, scarring, and allergic reactions to tattoo pigment, latex gloves, and/ or soap. Having been informed of the potential risks associated with getting a tattoo, I still wish to proceed with the tattoo application and I freely accept and expressly assume and all risks that may arise from tattooing.
