- 2. Every alternative public holiday and long weekend from 16:00 on the day preceding the public holiday or long weekend to 18:00 on the day of the public holiday or the last day of the long weekend;
- 3. Half of each short and long school holiday, including Christmas and New Year;
- 4. Half day of each birthday of the child;
- 5. Reasonable telephonic contact;
- 6. Mother's /Father's day and birthdays will be spent with respective parent;
- 7. Any other contact as agreed upon between the parties.
