TERMS & CONDITIONS

Flippin Fashions works on a 60-day contract, and you will receive 40% of the selling price. We make the consignment process fast and easy by accepting your high-end and or branded women's clothing, handbags, shoes, jewelry, sunglasses, and accessories while we do all the advertising, promotion, and transactions.

Store personnel have sole discretion in determining the selling price of your pieces with the assistance of our software curated for women's fashions. Our staff is trained to know what the store needs and what the latest trends are, so at times, we will graciously have to decline some items. We view each consignment as a partnership and acknowledge that it is in everyone's interest that we price your items based on style, brand, age, demand conditions, and fair market value. Items that are discovered to be damaged or flawed after initial inspection and acceptance will be sold at a discount or donated to charity.

Unsold items at the end of the 60-day contract will automatically become the property of Flippin Fashions if the consignor does not pick up their items within 5 days of the expired contract date. You must locate and retrieve your items from the sales floor as you are solely responsible for locating your items.

These unclaimed items will be sold on clearance or donated to a local charity at Flippin Fashions' discretion with no further liability, financial or otherwise, due to the consignor. Due to the VOLUME of consignors, you are required to keep track of the termination date, we do not call you when your items reach the end of the contract date. All items are left at your own risk. Flippin Fashions is not responsible for missing or damaged items.

Fashion reserves the right to discount merchandise during sale events and discount/clearance merchandise per season and or the length of time pieces have been in the inventory.

Once your items start selling, your funds can be used immediately for the purchase of items in Flippin Fashions, which are not transferrable to Flippin Furniture.

Consignor checks will be ready for pickup after the 15th of every month for items that sold in the previous month's sales activity. If requested to mail a check (s), FF will debit your account \$1.50 for each check mailed. The issued check must be collected by the consignor within 90 days, or the funds will be forfeited.

HOW TO CONSIGN:

Schedule an appointment with us by calling 303-972-3547 or stop in during our regular business hours.

Before you go through the time and expense of hauling your pieces over to our store, items must be freshly laundered or dry cleaned, free from pilling, pet hair, missing buttons, broken zippers, and most of all, free from odor and or smoke. We are a high-end women's resale boutique, not a thrift shop. Items that are discovered to be damaged or flawed after initial inspection and acceptance will be sold at a discount or donated to charity. Please note that we do not contact you in the event this occurs.

Please bring no more than 20 items total per week per consignor.

At the time of consigning your items, we will review them and follow up with an email that will list your recently consigned items and their initial prices, along with the end-of-contract date. Your items will reside on the floor for 60 days.
