



VENDOR AGREEMENT

- **Registration and Fees:**

- All booth fees are non-refundable.
- Tables and Chairs are NOT provided but are available for an additional charge of \$20 (size 8' X 30").
- Electricity is available for an additional charge of \$15. Booths with electricity are available on a first come first-served basis, and the number available depends on how they fit into the floor plan. You will need to bring an extension cord if you have a booth with electricity. (If you purchase but are not assigned a booth with electricity, we will refund the electricity charge.)
- Food will be available on site for purchase.
- No commissions are collected by Watson's Mystery Cafe and Spirits. Event sales are the responsibility of each individual exhibitor. Watson's Mystery Cafe and Spirits will not collect money on behalf of any exhibitor.

- **Watson's Mystery Cafe and Spirits will be responsible for:**

- Listing Watson's Barzaa in local publications.
- Providing you with electronic flyers for your distribution.
- Running the event and Serving/enforcing all Beverage and Alcohol laws

- **General :**

- Individual booth size is 10 feet wide by 10 feet deep.
- All vendors must submit examples of their work. Acceptable examples are a link to a website, an Etsy account, or a Facebook page. You may also submit photo examples of your work with your completed application.
- You are responsible for supplying any display props, shelves, tablecloths, etc. that you may want to use. All fixtures and all products must fit within your allotted booth area. It is not possible to display merchandise on the floor in front of or adjacent to your booth space or to block the aisles. This will be strictly enforced due to fire codes and heavy attendance.

- Tables will not be covered or skirted by Watson's. You may not damage walls, floors, tables or other Watson's property. No nails or tacks can be placed in the walls, and signs can only be hung using blue painters tape.
- You are responsible for staffing your table throughout the event.
- You are responsible for cleanup and removal of your merchandise at 6 p.m. You may not begin to disassemble until that time. Cleanup must be completed by 8 p.m. Please ask for assistance if needed.
- Any items left behind will become the property of Watson's Mystery Cafe and Spirits.

- **Limited Liability**

- Watson's Mystery Cafe and Spirits shall not be responsible for loss or damage incurred by the exhibitor by any cause whatsoever. The exhibitor must obtain their own theft insurance if it is desired. The exhibitor agrees to protect and save, harmless Watson's Mystery Cafe and Spirits, against any and all claims for loss, injury, or damage to persons or property arising from the activities of the exhibitor, his agents, employees or guests, defend Watson's Mystery Cafe and Spirits against any and all such claims, and to reimburse and indemnify Watson's Mystery Cafe and Spirits for any loss, damage, expense, or payment suffered thereby. Exhibitor's proof of Bodily Injury and General Liability insurance shall be made available upon request, and signer agrees that said insurance shall be in force during the event according to normal business practices, standards, and amounts outlined on this contract.
- Any and all licenses, city, county, state or federal, inspections or permits required by law of any exhibitor in the installation or operations of their display shall be the responsibility of the exhibitor, obtaining required documents at their own expense.
- Oil, gas, or diesel engines may only be operated only with the consent of Watson's Mystery Cafe and Spirits.
- All exhibits must comply with city or county ordinances of the local fire marshal
- Exhibitor warrants and guarantees to Watson's Mystery Cafe and Spirits that all ASCAP and/or BMI fees are paid for any music or covered material utilized in conjunction with their exhibitor space. Exhibitor agrees to save and hold harmless Watson's Mystery Cafe and Spirits from any and all disputes involving payment or non-payment of the aforementioned fees. Exhibitor agrees to defend and pay all costs incurred out of any action filed by ASCAP and/or BMI or any other party for collection or fees due
- Exhibitors shall not engage in any raffle, chance drawing, lottery, scratchy lotteries, etc., unless and until the Charitable Gaming Coordinator of the Idaho Lottery has given specific written approval of said activity.
- If a suit or action is filed regarding this contract, the exhibitor promises to pay Watson's Mystery Cafe and Spirits costs and reasonable attorney fees in such a manner as set by the court

- **Payment**

- Watson’s Barzaar Vendor Application, Applications, and check payment are due 5 Days Prior to the event unless another agreement is reached.
