OUR CASA STORY...

Libby Martin's 20 years of working in the education system guided her in selecting her first case as a CASA volunteer, advocating for 2 young children whose developmental and medical needs were not being met; one of the children was non-verbal and non-ambulatory.

After two previous foster care placements, the children were residing with a family member when Libby was appointed as their CASA, in the midst of the pandemic. While she had at one point dropped off some items to the caregiver, all of Libby's interactions with the children and others on the case was virtual.

The parents were ordered by the court to participate in and complete service programs to address their individual struggles. The mother had yet to participate a year into the case. The father, Michael, completed all ordered services and secured appropriate living accommodations for him and the children. With Libby's support he took action in meeting the children's needs; he attended ARD meetings, coordinated enrollment and transportation for school and acquired beds through Foster Angels. As a result of his efforts, Michael was granted weekend visits with the children.

Libby felt strongly that Michael had the ability to be a good father to his children under even difficult circumstances. Libby's testimony showed the court that Michael had effectively demonstrated his commitment to his children. The Judge ordered permanent custody to Michael, reuniting a family.
