

REVHEADS COMPETITION

Terms & Conditions

All competitors **MUST** register and pay **BEFORE** competing. Nomination fees are \$80 per driver. Payment details are listed on the entry form. Gate fees are separate and must be paid upon arrival.

By nomination and paying entry fees you will be bound by the following rules of Narrogin Revheads Inc:

- **The burnout competition will commence at approximately 1pm Friday, if you cannot make Friday please notify us and we will allow you to skid your two qualifying skids on Saturday**

- 24 hours notice must be given if you are unable to attend. If failing to do so, the \$80 entry fee will be forfeited.

- All entrants MUST hold a current AASA - Extreme Event Licence or General Speed Licence
- All entrants must comply with the attached AASA Burnout Event Supplementary Regulations
- The same competitor cannot nominate the same car more than once in that class
- Your vehicle must have a fire extinguisher per AASA rules
- Each driver must complete their own entry form

- No oil is to be used in the burnout competition and burnouts must be performed in an orderly and controlled manner. Any driver deemed not in control of the vehicle by officials will be immediately disqualified and ordered to stop.

- Your time limit will start once you enter the burnout pad and given the go ahead from officials. You will be given a maximum of 2 minutes to complete your burnout.

- Only 1 passenger permitted in the car each burnout. All passengers must register separately. You must all be wearing seatbelts and the appropriate attire must be worn (helmets, closed in shoes, long sleeve shirt, long pants).

- Maximum of two engine stalls will be allowed. After the second stall you will be asked to leave the pad.

- After your time is up, orange flashing lights will come on around the pad. You MUST leave the pad in a careful manner. If failing to do so, points will be deducted.

- Any person found to be driving recklessly or in a dangerous manner from the pit to the burn-out pad, will be automatically barred from competing in the days competition.

- Competitors must follow official's instructions at all times.

- The car must be on the move at all times.

- All wheel studs and nuts must be checked and tightened before any burn-out. No wheel weights permitted.

- Competitors will be judged on the basis of a minimum burnout period of 1 minute (60 seconds). Any burnout less than 40 seconds will receive a Did Not Finish classification (DNF).

- All judges scores from the 2 heats will be added to determine your total score.

- The judge's decision is final.

- No liability is accepted for any damage to your vehicle.

- As a competitor in this event, you owe duty of care to spectators and the public. On signing the Terms & Conditions, you have recognised and accepted that duty of care.

- Your vehicle must be in good working order. It is your responsibility to ensure your vehicle is in a safe condition. Officials have the right to disqualify your vehicle should it be deemed unsafe.

- As a competitor, by signing this you indemnify any liability to Narrogin Revheads Inc and acknowledge motor sport is dangerous and you compete at your own risk.

Conduct and Driving Standards: If your speech or behaviour is noticeably impaired, it is reasonable for Narrogin Revheads Pit Crew to believe you are intoxicated or under the influence, you will be REFUSED entry onto the burnout pad.

Every competitor deserves the right to compete therefor : each competitor is expected to have a level of respect for their fellow volunteers, other competitors and the crowd.

On accepting passengers you accept the responsibility and have a duty of care of those passengers.

I hereby certify that I am the owner of the vehicle or authorised agent for the owner of the vehicle, that the vehicle is in safe order and that I have read and accepted the Terms & Conditions of entry. I enter this competition in good faith.
