Dear Siblings in Christ,

It has been a challenging year for us all. As the fog slowly lifts from Covid-19, we realize that our landscape has changed. Pre-Covid, Sunday mornings were a time of fellowship and worship, catching up on the events of the prior week with each other while post-Covid, many are staying home and avoiding gatherings to protect their health. Although this is understandable, it is painful to see. Others, because of the pandemic, have found different ways of filling their time on Sunday morning and have started new routines that don't include church. This too is painful to see. There are others who have stopped coming for various other reasons, maybe hurt feelings or disagreements, this is always painful to see. As siblings in Christ, we shouldn't let such things keep us from going to church and deter us from coming together. Remember the words from Peter, Summing up: Be agreeable, be sympathetic, be loving, be compassionate, be humble. That goes for all of you, no exceptions. No retaliation. No sharp-tongued sarcasm. Instead, bless — that's your job, to bless. You'll be a blessing and also get a blessing. — 1 Peter 3:8-9 (MSG) Regardless the reason, attendance has diminished, and it is heartbreaking.

Even with all the apparent negative changes to our landscape, we cannot give up hope or forget that we are never alone. We must also remember why and for whom we come together. We are together because God calls us together. God calls us together, not only as a church family, but as a parish family, to be the body of Christ. To not only grow in the Holy Trinity, but to allow the Holy Trinity to grow in us as we serve each other, and the rest of God's creation as God calls us to.

Recently, a group of us completed studying the book, Sailboat Church by Joan Gray. The book helped to remind us that we need to work with the Holy Spirit to move us forward with Jesus at the rudder steering us through life. Too often, we feel like we need to tackle the issues we face, like reduced attendance, on our own and forget that we really need to take our hands off the oars, and to raise the proverbial sails and allow the Holy Spirit to move us forward. As we begin to realize this and slowly take our hands off the oars and raise our sails, we are beginning to see new things that we couldn't see before. For example, in Osawatomie, the session is exploring how to become a truly open and affirming congregation. They've also realized the importance of relationships and are working to bring deacons back to help in maintaining relationships, rebuilding relationships and kindling new ones.

In Paola, even as we seek to sell the building, the church family there has realized that the building is not the church. That even if the building is sold, there's still a possibility that the church will continue. Although the beautiful building will be missed, the memories remain and the beautiful church family, remaining focused on God and trusting the Holy Trinity, will continue as long as God deems it and as long as the congregation remembers to let God fill the sails and steer the church forward.

Miami continues to also sail forward under the power of the Holy Spirit, looking for ways to help those in need within our community and seeking to spread the gospel beyond the walls of the church building.

And the parish, as a whole, continues to move forward under the power and guidance of the Holy Trinity. Coming together to plan outreach and fellowship events, special worship services and opportunities to grow in our faith through studying scripture and Christ centered discussions.

Remember the words from Proverbs 3:5-6, "Trust God from the bottom of your heart; don't try to figure out everything on your own. Listen for God's voice in everything you do, everywhere you go; he's the one who will keep you on track. Don't assume that you know it all. Run to God! Run from evil! Your body will glow with health, your very bones will vibrate with life! Honor God with everything you own; give him the first and the best. Your barns will burst, your wine vats will brim over. But don't, dear friend, resent God's discipline; don't sulk under his loving correction. It's the child he loves that God corrects; a father's delight is behind all this." (MSG)

My heart, thoughts and prayers are with each of you, even if you think they aren't. I care deeply for each of you, and I appreciate and thank God for each of you.

Siblings in Christ, please join me in looking forward to the year ahead, not because of where we are, but because of where God is taking us. Together, may we look forward to what God has in store and to being a part of making it happen.

WORSHIP COMMITTEE 2022 Annual Report

The Sacrament of the Lord's Supper was served by Rev. Paul Davidson on Jan. 6, Feb. 6, March 7, April 3 (Easter), May 1, June 12, July 3 All Parish service at Miami Pres., Aug. 9, Sept. 4, Oct. 2 All Parish Service here, Nov. 6 and Christmas Eve.

Gail Jones from Paola Pres. Has been playing the organ for services the third Sunday of the month and special services such as Easter, Christmas Eve and Parish Services here. Member Martha Bogart has been playing piano for most all other Sunday services.

Organ and baby grand piano are regularly serviced and tuned as needed.

BUILDING and GROUNDS COMMITTEE 2022 Annual Report

In December we had one frozen water line in the second floor kitchen because the heat was not functioning correctly during a sub zero temperature occurrence. It was thawed with no breakage.

Flower beds were maintained and some plants replaced by church volunteers.

Church yards including the lot to the east were kept mowed and trimmed.

That furnace has been repaired and is now functioning correctly.

We will need to replace the AC air handling units. Quotes received ranged from \$19,000.00 to \$24,000.00. That pricing is expected to increase with the new year because of additional regulations on AC units. The session will be starting a capital campaign to raise the funds to fix.

We still need to repair and paint the ceiling and remove/replace the carpet.

The west outside water faucet was replaced because of a constant leak and the east outside water faucet had a locking cover put on it.

There was wind roof damage (missing shingles) in the summer that resulted in a leak and water damage to the second floor ceiling in front of the elevator. Sam Inscore replaced the shingles and fixed the leak.

TECHNOLOGY COMMITTEE 2022 Annual Report

We now have a permanent computer for the AV room to display service info on the big TV/Monitor as well as able to run Zoom or video conferencing using church AV systems.

One memorial service was available via Zoom this year and starting with the Christmas eve service our weekly Sunday services are being streamed on the Parish you tube channel. We will be fine tuning that process.

First Presbyterian Women's Group 2022 Annual Report

Due to continued Covid-19 concerns, the Presbyterian Women's Group did not meet in person as much as we would 've normally done, but we were able to complete some key mission opportunities for the community and did do a few short informal discussions during church.
