

**MOJAVE DESERT GEM AND MINERAL SOCIETY  
2020 DEALER SPACE CONTRACT  
BARSTOW SHOW**

This contract is made between the Mojave Desert Gem and Mineral Society (hereinafter referred to as the Promoter) and \_\_\_\_\_ (hereinafter referred to as the Dealer).

1. The **Annual Barstow Gem and Mineral Show** will be held at the Barstow Community Center, 841 South Barstow Road, Barstow, CA 92311. The show will be open December 5 and December 6, 2020 from 10:00 a.m. to 5:00 p.m.
2. Dealers may set up their displays on Friday, December 4 from 11:00 a.m. until 8:00 p.m., and on December 5 from 8:00 a.m. until 10:00 a.m. An attendant must remain in the booth during show hours. Dealers will not remove their displays before 5:00 p.m. on Sunday, December 5 and removal must be completed by 8:00 p.m. the same day.
3. The cost of the booth is **\$280.00** for **30** feet with backup tables or **\$350.00** for **40** feet with backup tables. Full payment must be made and returned with this contract by **November 1, 2020** to reserve your space. Make your check payable to the **Mojave Desert Gem and Mineral Society** or **MDGMS**.
4. A minimum of 1000 watts electricity (at 100 volt, 60 cycle, A.C.) will be furnished to each dealer space.
5. Promoter will provide security from 1:00 p.m. on set-up day until 8:00 p.m. on Sunday. Promoter assumes no liability for safety of dealers, their employees or exhibits from robbery, pilferage, damage by fire, water, accidents, or any other cause or causes. Dealers who wish to insure against damage to their property will do so at their own expense. Dealers will indemnify and hold the Promoter harmless from any and all liabilities arising from or in connection with installation, operation or removal of their materials or equipment.
6. Materials and equipment offered for sale must be correctly represented and labeled. Sales and solicitations are permitted only by authorized dealers leasing space in conformity with this contract. Sales will be limited to merchandise or services for use in lapidary, gem, mineral, or related hobby fields. No sub-letting or reshaping of booths will be permitted without prior approval in writing from Promoter. Sales prices established at opening of the show will remain for the duration of the show.
7. The Promoter reserves the right to make changes, amendments or additions to the terms and conditions of this contract as may be considered necessary for the proper conduct of the show.
8. If the show should be canceled for reasons beyond the Promoters control, this contract shall be limited to the refunding of monies paid by the Dealer. In the event of cancellation or non-compliance by the Dealer, Promoter will determine if any monies paid by the Dealer will be refunded
9. Please sign and return this contract with payment by **November 1, 2020** to ensure your booth is reserved.

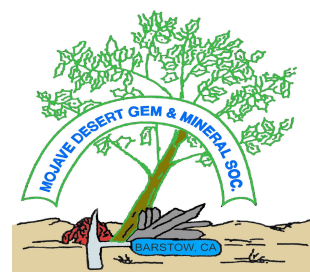
