# From the city of Concord:

- The Parks and Recreation <u>Spring 2023 Leisure Times</u> Issue is <u>available and</u> registration is open for upcoming programs. Check out the activities, services, and events for all ages being offered this spring in the City of Concord. Find information about some of their popular programs like the Bunny Run, Pickleball, and youth athletics inside.
- The 2023 Recycling and Bulky Waste Calendar is now available to download <a href="here">here</a>. Beginning in July, the city will bring residential solid waste services in-house and we will switch to a 4-day work week rather than the 5-day work week we have now. City crews will begin providing collection of all garbage and recycling in place of our current contractor. This change will allow us to have direct control over all services, provide a more consistent collection schedule on holiday weeks, improve efficiency and flexibility, and allow us to mobilize quickly to meet emergencies or other special circumstances.



## CPR Training available - Free of charge!

Since we are a designated "Community Organization," we will be able to host a free CPR class from the City of Concord Fire Department staff! Dates are open for February and March of 2023.

Our neighborhood may set the time, date and location for the CPR training. I (Jim Bernacki) will try to secure Center United Methodist Church, at the corner of Old Airport Rd. & Rte. 3/Branchview Dr. If this isn't available, we can apply to use the Sherrill Center at 2228 Lawndale Ave. SE.

In order to have this class, we need at least 6 confirmed attendees from our neighborhood. If you sign up for this free course, I will email you a note asking for some information, along with a list of possible dates, times, and places for the course. The training is approximately two hours, and if you wish, official CPR certificate cards will be available for interested participants for the cost of \$19.
