# \*\*\* COVID-19 Guidelines\*\*\*

NACSW is requiring that all attendees adhere to social distancing - maintaining 6' of distance - at all trials until further notice even if your jurisdiction has relaxed their requirements or recommendations. Social Distancing requirements at an event are MANDATORY. There is *no option* to mutually consent to be closer together than 6'. Please be respectful that your proximity or request for proximity may make others uncomfortable. Please review the document <u>COVID-19 Event Guidelines</u> that is located in Google docs and was emailed to the membership on 5/8/2020.

In addition to those guidelines the following changes and guidelines are in effect for this trial due to COVID-19.

- All attendees (participants and volunteers) will be required to bring and wear face masks in the search.
- Participants are asked to remain in their vehicles as much as possible.

- Participants are asked to bring their own hand sanitizer and disinfecting wipes.
- If there are any changes or updates that information will be included in your final details information that will be emailed 1-2 weeks before the ORT weekend.

#### **Entries Close**

#### Tuesday, May 11, 2021 at 10:00 are Mountain Time or when entry limits have been met

#### Second Dog Policy

All three odors will be offered before noon for approximately half of the participants. The remaining participants will run their dogs in the afternoon. All three odors will again be available. This allows a contestant to run one dog in the morning and a second dog in the afternoon, both on one, two, or three odors. No dog may run on the same odor twice during the day. Assignment of morning and afternoon slots will be at the discretion of the host to ensure maximum efficiency. This schedule is subject to change depending on registrations. Final details will be sent by email one week before the ORT.

#### Entry Method

Entries will be accepted in the order received by USPS mail.

Mail overnight deliveries must have the signature waived box checked.

#### Entries

- TELEPHONE, FAX, UNSIGNED ENTRIES, AND ENTRIES RECEIVED WITHOUT FEES cannot be accepted.
- RETURNED CHECKS do not constitute a valid entry fee. There will be a \$25 fee for returned checks.
- ENTRIES MUST BE MADE ON THE ENTRY FORM UNDER THE REGISTRATION TAB.
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.
- OWNERS are responsible for errors in making out entry forms.
- EXPRESS MAIL entries must include signature permitting them to be left at the secretary's address without recipient's signature.

#### Notification

Acknowledgement of entry acceptance/confirmation, will be made by email when entries are processed for those handlers that provide an email address. If you require a confirmation via USPS, you must provide a self-addressed stamped envelope with your entry. Your payment receipt and notification is confirmation of your completed entry.

#### **Test Site Hours**

The building will open at 7:00 am MT. CHECK-IN for competitors will be at 8:15 am MT. The handler briefing will follow check-in. Details regarding check in time and briefing will be sent out one week prior to the ORT. Please do not plan to arrive before 8:00 am MT since volunteers will not be available to direct parking.

#### Entry Requirements A Qualified Entry is one that meets <u>all</u> the following criteria:

- 1. Complete entry during the specified entry timeframe.
- 2. The Handler is a NACSW<sup>™</sup> member for the 2020-2021 membership year (8/1/20- 7/31/21).
- 3. The Dog is registered with the NACSW<sup>™</sup>.
- 4. Dogs participating in an Odor Recognition Test (ORT) must be at least six months of age.

### **Trial Eligibility and ORTs**

An ORT must be taken and passed at least 14 days before a trial opening date to be eligible for the first draw period.

### **Basic Description of Test**

To successfully pass an ORT a dog must identify the location of the target odor and the handler must correctly call an "alert" within a three-minute time period. The Odor Recognition Test consists of a drill type exercise which requires 12 closed boxes set up in a pattern of *one or* two rows, spaced a minimum of 48" apart. The ORT is conducted on leash. Complete information can be obtained on the NACSW<sup>™</sup> website.

### No dog will be given more than one space in the same odor test at a single event.

#### Results

During the odor re-sets, the official results sheet will be brought out to the parking area for testers to photo or review. We recommend you verify your results on the official results sheet and let your host or judge know if you have any questions regarding your results.

#### **Refund and Cancellation Policy:**

For cancellation of entries on or before 5 pm MT, May 11, 2021 – a full refund minus a \$5 processing fee will be returned to the competitor. For cancellation of entries after 5 pm, May11, 2021, a refund minus the \$5 processing fee will only be issued for a medical emergency if a note is provided from a doctor or veterinarian.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, or excused by the NACSW<sup>™</sup> official or judge.

This cancellation and refund policy applies to competitors that must withdraw for any reason including but not limited to injury, illness, emergency, and personal or work-related reasons.

If the Odor Recognition Test (ORT) cannot take place or be completed by reason of fire, civil disturbances, an Act of God, public emergency, or any other cause beyond the control of the ORT organizers, then the ORT host will make their best effort to provide partial refunds after recouping their expenses.

## **Site Specific Conditions**

This ORT will be held in a church meeting hall/gym. The parking lot is partially paved and partially dirt. The testing area is on the same level as the parking lot. The flooring in the test area has a hard, non-slip surface. Restrooms are available inside the church on the parking level. The pathway to and from the parking lot to the test area may require you to navigate uneven terrain, including gravel and asphalt walkways. The planned exit path from the test area includes outdoor stairs leading to the side parking lot and a short return to the main parking area. Special accommodations may be made for an exit on the parking level. Due to unforeseen conditions, such as weather or change in availability of areas at the location, the expected test area, parking, and/or pathways may be modified at the last minute.

#### **Reactive Dog Parking**

There will be reactive dog parking at this test for those who wish to park in this area, however the parking is tight and there will not be separate potty areas or warm up boxes.

Due to unforeseen conditions, such as weather or change in availability of areas at the location, this policy may be modified at the last minute.

#### **Unentered Dogs**

Unentered dogs must remain in the competitor's vehicle during the test day. There will be ample potty areas, but unentered dogs should not be allowed to "play", exercise, or train on the test grounds.

## **RV** Parking

There is space for RVs to park in the competitor parking area during the test day. To reserve a space, you will need to contact the host after you receive a confirmation that you have received a space in the test. Email <u>k9nosinaround@gmail.com</u> to reserve RV space. No overnight RV parking is available.

Due to unforeseen conditions, such as weather or change in availability of areas at the location, this policy may be modified at the last minute.

## Running Vehicles or Generators in the parking lot

The parking is tight at this location and running your vehicles or generators in the parking lot is not allowed at this test. Due to unforeseen conditions, such as weather or change in availability of areas at the location, this policy may be modified at the last minute.

#### **Dog Policies**

- All dogs must be on a 6' leash at all times when not being tested. NO flexi-leashes while not
  participating in a test.
- Reactive and/or spatially challenged dogs should wear a red bandana (to be provided by the dog's handler) to help signal others that the dog needs extra space from other dogs.
- Dogs will be toileted in designated areas and handlers must pick-up and dispose of waste.
- Dogs and handlers must stay in designated areas to avoid contaminating testing space, interrupting a test, or from viewing any part of the testing.
- Competitors should expect to keep their dogs confined in a crate or vehicle when not testing and should plan to provide their own shade using canopies or shade cloths.

#### **Females in Season**

Will be allowed to run wearing "pants" at the very end of the running orders in the afternoon after all other dogs have been judged. Females in season will be parked and pottied in areas separate from the other dogs while at the test if the location logistics permit. Handlers must contact <u>k9nosinaround@gmail.com</u> so plans can be made for the dog.

#### **Spectators**

To minimize the number of people on site, anyone not volunteering, competing, or officiating should stay home except in the case where someone **requires** support to travel to the event. Spectating is currently not allowed. An adult accompanying a minor must be present during the searches. Everyone at the trial site must sign the waiver provided by the host and comply with all event requirements.

#### Smoking

Smoking is not allowed on this test site, including the use of e-cigarettes

The competitor also agrees to assume all financial liability that may be incurred by the NACSW™ due to the actions of themselves or their dogs regardless of the cause.

#### **Sportsmanship**

All competitors/handlers and spectators are expected to follow the rules of the NACSW<sup>™</sup> and demonstrate good sportsmanship. This includes making sure the hide placements are unknown to the handler prior to testing and kept secret from other competitors. Please do not discuss hide placement or any details of a dog's performance that may provide information or clues to other handlers or may be overheard.
