FIRST AID

GENERAL INFORMATION

WITHSTAND NG is an oil-emulsion based deposition aid and drift control agent that enhances the canopy penetration and leaf surface coverage of crop protection product applications.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using WITHSTAND NG the applicator or crops advisor must have experience with the pesticide combination, including WITHSTAND NG or must have conducted a phytotoxicity test.

USE RATES

For use with herbicides, insecticides and fungicides.

- 4-6 oz. per acre in 5-20 GPA applications.
- 6-8 oz. per acre in 20-40 GPA applications.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry DRAs
3. Dry soluble and suspension fertilizers / micronutrients
4. **WITHSTAND NG** and flowable formulations (F & FL)
5. Liquid concentrates, suspension concentrates, micro-encapsulated and capsule suspensions (LC, SC, ME, CS)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

ENVIRONMENTAL HAZARDS

Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water when cleaning equipment or disposing of equipment wash waters.

STORAGE AND DISPOSAL

This product does not require heated storage. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container.
