## 4. FIRST AID MEASURES

---

## 5. FIREFIGHTING MEASURES

---

Suitable Extinguishing media: Water fog, dry chemical, foam, CO<sub>2</sub> or halon. Water stream may splash the burning liquid and spread fire.

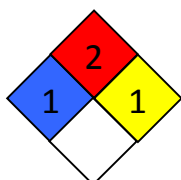
