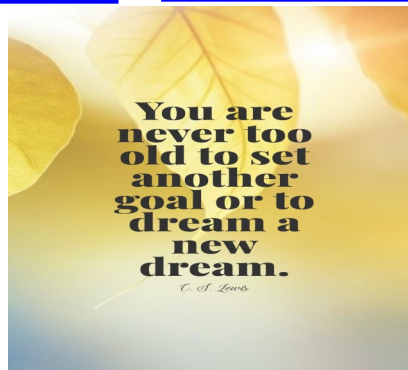

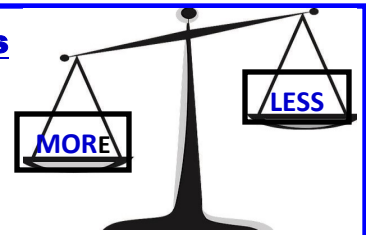

If he wins the election Biden has time for things to cool down-and can later commute or pardon son Hunter's sentence if his sentence is long term imprisonment . He has promised to do neither. If he didn't keep to his word in that case, he might have to resign and Kamala becomes President . Or if Biden loses in November he can pardon or commute Hunter's sentence in the closing days of his current presidency before Jan 20, as Trump did for Roger Stone. What would you do for your son?

Did Hunter Biden have advantages throughout his life that many don't, as a Biden family member ? He did. But he also had the trauma of grief and loss. His mother and sister died in an auto accident in which he was a passenger when he was a child, but he survived. Then his brother Beau died in later years, a serious loss to him and the family. But these cannot be excuses.

The family hopes this and perhaps another upcoming conviction in California does not set Hunter back in his recovery. After the Delaware verdict President Biden had no real choice but to retain his integrity and the integrity of the courts. And to try to love him unconditionally. His son's illness has forced him into a choice between the urge to protect a child and the public responsibility to uphold the law. What a terrible place to be!

Battling a substance abuse disorder is viewed by many as a personal experience. But harmful drugs have devastating effects on not just the user. Others must be considered. Spouses, children and parents may all be impacted by the way addiction affects the family. Peaceful, loving homes can be divided by the strain caused by drug (and alcohol) abuse. Conflict becomes normal. Trust begins to erode. Relatives may become more guarded if a relative abusing illicit drugs acts with aggression, crime, or hides their disorder in secrecy. Marriages and family ties can suffer and end due to changes caused by addiction. Communication becomes more difficult, and frustration ensues. The Biden family is no exception and have likely been affected in similar ways.

President Biden has that rare opportunity inherent in his powers to rescue his own son from possible long term imprisonment during his prime years. What might be the fallout for Biden, the rule of law, and the Democratic party's future by exercising that pardon power?

We can anticipate a victorious Trump pardoning the Jan. 6 convicted felons as he has announced many times. And we might compare their status to Hunter Biden's or to Donald Trump's felon status. Perhaps President Biden's pardoning of son Hunter AND Donald Trump at some point would result in less clamor and be more acceptable to Americans.

For the Bidens this could be worthwhile whatever the cost-for this family who demonstrates at every turn their love and support for each other. For Trump it could be a life changing lesson in spiritual forgiveness he'd never attain from his fake \$99 bibles he's never read. But then both Trump and Hunter Biden would no longer be held accountable.

I believe the 2024 election is a choice between integrity vs dishonesty, and decency vs rudeness. May God be with and guide President Biden in the coming months an year as he faces the toughest time of his life.

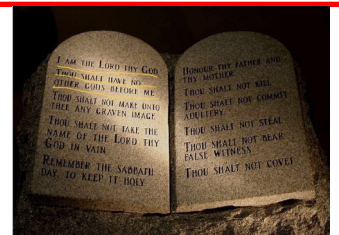

Legislative Update for District 96:

On Tuesday, May 7, State Senator Tina Polsky and I held a town hall meeting in the Commission Chambers at Coral Springs City Hall, where residents were able to learn about the recent Legislative Session and voice their comments, questions, and concerns directly to their legislators. The Senator and I started with a brief Session overview and then spent time answering questions. The main issue attendees wanted to hear about was property insurance, and unfortunately there isn't much good news to share on this front. While many good proposals were put forward by the minority party, these proposals did not get the hearing they deserved. We will continue to work on this important issue.



My legislative priorities for 2024 began with Jaime's Law, which I have filed yearly since 2019. **HB 145** would require background checks on the sale or transfer of ammunition to help prevent tragedies like the one that took the life of Jaime Guttenberg, the bill's namesake, at Marjory Stoneman Douglas High School in 2018.

Some additional bills I introduced:

HB 161 Payments for Health Care Providers and Surgical Procedures under Workers' Compensation: increases maximum amounts of certain witness fees related to workers' compensation cases; increases maximum reimbursements for physicians and surgical procedures under workers' compensation. This is the first substantive change to the workers' compensation system in 25 years and will encourage more providers to enter the space. This bill was passed and signed into law.

HB 765 Leave of Absence to Officials and Employees: Provides that certain public officials and employees may receive full pay for leave of absence relating to active federal military service that lasts a certain length of time. This bill passed and as of this writing is waiting for the Governor's signature.

HB 903 Educator Certification and Training (Expanding FERTES): Revises provisions relating to teacher and educator preparation programs, educator certification requirements, and educator inservice training to require certified educators to receive training relating to mass casualty incidents. This bill will be filed again next year.

HB 915 Outpatient Mental Health Services: Empowers courts to order outpatient treatment for misdemeanors, enhances criteria for involuntary inpatient placement, and emphasizes continuous monitoring and evaluation. This bill was incorporated into HB 7021 and ultimately passed.

HB 983 Public Records Exemption for Clerks of the Courts: Introduces an exemption from public records requirements for personal identification and location information of current or former clerks of the circuit court, their deputy clerks, and personnel. Notably, it extends this protection to their spouses and children as well. This bill passed and is awaiting the Governor's signature.

HB 999 Post Trial Counseling Services for Jurors: Creates an optional post-trial counseling program for jurors who have experienced testimony of a disturbing nature.

To summarize, the Legislature passed a number of the bills I sponsored this past Session, more than that of any other Representative from the Democratic Party. I was also able to secure 1.6 million dollars in the 2024 State Budget on behalf of my constituents. As a public servant, my number one goal is to benefit both our community and the state.

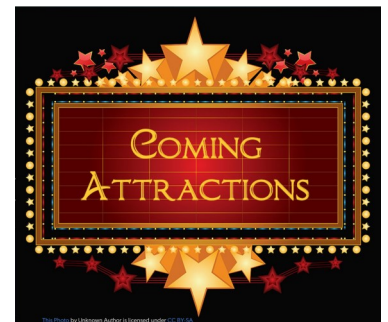

Trying to figure out how to respond makes the opponent look confused, because they don’t know where to start grappling with the flood that has just hit them.

It is a form of gaslighting.

******“GISH GALLOP”******

Please, please get the word out to everyone about the debate the other night and why Biden behaved as he did. Even a 30-yr old would have behaved the same way. As always tRump did not play by the rules of a proper debate. This is what he did:

(1) The Gish Gallop (/ˈɡɪʃ ˈɡæləp/) is a rhetorical technique in which a person in a debate attempts to overwhelm their opponent by providing an excessive number of arguments with no regard for the accuracy or strength of those arguments. Gish galloping prioritizes the quantity of the galloper’s arguments at the expense of their quality. The term was coined in 1994 by anthropologist Eugenie Scott, who named it after American creationist Duane Gish and argued that Gish used the technique frequently when challenging the scientific fact of evolution.

Strategy:

(2) During a Gish gallop, a debater confronts an opponent with a rapid series of specious arguments, half-truths, misrepresentations, and outright lies in a short space of time, which makes it impossible for the opponent to refute all of them within the format of a formal debate.

(3) Each point raised by the Gish galloper takes considerably more time to refute or fact-check than it did to state in the first place, which is known online as Brandolini’s law.

(4) The technique wastes an opponent’s time and may cast doubt on the opponent’s debating ability for an audience unfamiliar with the technique, especially if no independent fact-checking is involved or if the audience has limited knowledge of the topics.

No wonder Biden responded the way he did. Absolutely no one who isn’t aware of this strategy would have behaved the same way Biden did.
