# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to scotomasecurityapplication.com, and Scotoma Technologies and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Scotoma Technologies include scotomasecurityapplication.com, Scotoma, Macula Technology, maculatechnology.com and maculatechnology.com. # **Collection of your Personal Information**

In order to better provide you with products and services offered, Scotoma may collect personally identifiable information, such as your:

- Comply with the California Electronic Communications Privacy Act;
