OBJECT OF THE CONTRACT:


1. TO PICK UP DOMESTIC GARBAGE IN THE MUNICIPALITY OF PORTAGE DU FORT.
2. TO START PICK UP AT 8:00 AM ON EVERY SATURDAY MORNING AND NOT STOP UNTIL THE PICK UP IS COMPLETED.
3. TO PICK UP AT ALL RESIDENCES, IN THE TERRITORY OF PORTAGE DU FORT.
4. TO BRING THE GARBAGE TO TOM ORR'S DUMP SITE IN CLARENDON.
5. GRASS CUTTING AND TRIMMING WILL START IN THE SPRING AND END IN THE FALL.
6. STREET SWEEPING WILL START IN MAY UNTIL COMPLETED.
7. THE PAYMENT OF THE CONTRACT IS MONTHLY.
8. THIS CONTRACT IS FOR A PERIOD OF 3 YEARS. IF NEED TO TRANSPORT GARBAGE TO ANOTHER AREA, THE PRICE IS SUBJECT TO CHANGE.
9. THE MUNICIPALITY WILL KEEP THIS CONTRACT IN PLACE FOR 3 YEARS WITH GUARANTEE OF SERVICE REGARDLESS OF THE MUNICIPAL STATUS.
10. THE CONTRACTOR GUARANTEES TO FULFIL HIS DUTIES DURING THE 3 YEARS AND IF HE CANNOT FULFIL HIS CONTRACT HE IS TO FIND HIS OWN SUBSTITUTE.
11. THE CONTRACT STARTS ON APRIL 1, 2018 AND IS IN PLACE FOR 3 FULL YEARS.
12. THE CONTRACTOR AGREES TO FULFIL THIS CONTRACT IN FULL. HE WILL ALSO ENSURE HIMSELF THAT HE FOLLOWS ALL PROVINCIAL REGULATIONS CONCERNING ROAD LAWS AND REGULATIONS.
13. CONTINGENT ON THE USE OF THE TOWN GARAGE FOR WORK RELATED ACTIVITIES.
