Article 1	The following real estate tax be imposed and levied annually for the 2018 financial year on all taxable property of the municipality;
	Real estate tax 0.095/100\$
Article 2	From and after the coming into force of the present bylaw and until it has been repealed, the real estate tax will be imposed by resolution.
Article 3	WATER SERVICES TARIFF
	The following annual tariff be imposed and levied for the 2018 financial year of all those receiving water services;
	Residential 830\$/unit
	Residential with commercial +300\$
	Commercial/Motel/Hotel 930\$/unit + 200\$/room
Article 4	GARBAGE SERVICES TARIFF
	The following annual tariff be imposed and levied for the 2018 financial year of all those receiving garbage services;
	Residential 180\$/unit
	RECYCLING SERVICES TARIFF
Article 5	The following annual tariff be imposed and levied for the 2018 financial year of all those receiving recycling services will be a flat rate for residential it will be 21\$/unit

	SERVICE DEBT FOR INFRASTRUCTURE
Article 6	The following annual tariff be imposed and levied for the 2018 financial year of all those owning property in the municipality of Portage du Fort will be a flat rate for all it will be 659\$/users and 233\$/non-users.
	LAUNDROMAT SERVICES
	The following annual tariff be imposed and levied for the 2018 financial year of all those owning property in the municipality of Portage du Fort will be Commercial rate of 930\$ + 75\$ per washer.
Article 8	FIRE PROTECTION SERVICES
	The following annual tariff be imposed and levied for the 2018 financial year of all those owning property in the municipality of Portage du Fort will be a flat rate for all it will be 240\$.

This by-law shall come into force according to the law.
