2. Parish Finances

a. Presentation of Financial Reports: Debi

Financial Reports were reviewed and accepted as presented. Motion by Mary, seconded by Karen.

b. Discussion on investment interest:

Cemetery investment - last month interest was \$129.74, which was sent to Parish. Will continue to receive monthly interest income. When the amount in the cemetery balance reaches \$3,500 will begin to leave the interest amounts in the account, will revisit in Fall.

c. Debi reported that the Parish Audit is complete and asked for the Trustee's and Father to remain after this meeting to meet and discuss.

d. Rectory Office blinds:

Mary Joyce donated towards the purchase of blinds for the office. Karen K. stated that she needs assistance to complete the measurements and ordering of the blinds.

3. Parish Needs

a. COVID-19 – Any updates – Fr. Evans

Can begin to hold funeral luncheons – up to 50 people indoors and 6' distancing

Mary J. indicated that she attended a Mass that parishioners nodded to each other instead of hand shakes. Wondered if we were at that point yet? Fr. Evans indicated that we are not quite there yet.

b. Lenten project: Deliver Soup Supper Results: Jean

The Lenten Project of delivering Soup to parishioners and community members was a success. We received over \$200 in donations and delivered weekly to 79 people. Will look at doing something similar next year – serve at parish and only deliver to home bound.

Virtual Spring Fling results were positive – the online Auction was a hit. Plans are to have the same process next year.

4. Buildings and Grounds

- a. Chimney repair: Update on Quote from Vendor (s) -- Bill F.
Bill: left numerous messages to determine date project to be done. Jeff Graf has agreed to the use of his lift for the work.
- b. Furnace Repair Update: Butch
Replaced fins -- \$513 expense
- c. Butch's Updates:
 - Cemetery Garage Roof Project: Butch will pick up second hand shingles at Habitat Store
ACTION: Butch will be shingling the cemetery garage roof. Cost is expected to be \$500 in product and \$0 in labor.
 - Sacristy Ceiling Tile Project: Randy Mell and Butch completed project the end of February.
 - Lawn Cutting: going well this season. Currently prepping for Memorial Day at the cemetery grounds.
 - Door to Hall Kitchen Project: large dip at outside entrance -- Butch will repair dip.
 - Cleaning floor of Hall – Butch will rent a machine and complete by July.

- d. Youth Services:
 - National Day of Prayer: 3 youth participated
 - Camp Summit is in August:
One day event for 6-8 grades. Currently have 7 students who would like to participate. The cost is \$75/person – the families would pay \$25 each and a M&M fundraiser would occur in May, June, and July to raise the \$50 cost. The Parish funds will pay for the cost of the Chaperones. Chaperones are Debi, Butch, and Angie TenKley.

Nichole Carlon was nominated as a candidate for the second trustee position.
- b. Cemetery Property lines: Fr/ Matt Weinbender
Matt was not present but had discussed his thoughts to Butch:
Matt had the adjoining acreage (his property) surveyed with GPS and it appears that a portion of Matt's property is within the cemetery boundaries. Matt is willing to give a triangle portion to cemetery and a long portion that is in field would go to Matt. Matt would work with a lawyer and St. Patrick's to address property lines and share costs of lawyer with St. Patrick's.
Karen K. offered to speak with County Surveyor in case there are any issues that need to be considered in the process.
