### NEWS AND INFO FROM OUR GOVERNMENTAL ALLIES

# MCSO River Patrol - Sergeant Matt Adams

5 boats will be patrolling during the Fourth of July weekend. They experienced an increase in calls due to Fleet Week and a rise in stolen boats. (RPU deputies have recovered 2 stolen boats in the past few weeks). They assisted with a homicide on Hayden Island. There was a discussion on whether the area the body was found is owned by the DSL or Port of Portland. DSL said that if the Port of Portland does not own it, it likely defaults to them. Multiple members discussed boaters not following wake and speed rules. MCSO recommends having multiple people call in to non-emergency for a quicker response time for any non-emergency incidents on the river.

### Portland Fire Harbormaster - Sean Whalen

Sean was present for Fleet Week, where about 2,500 people per day toured visiting ships. River Patrol and the Coast Guard were present to help.

There was a Fire Boat Renaming Event for Station 17 renaming their rescue boat the "Jerry Richardson". Lt. Jerry Richardson passed away from workplace cancer a couple of years ago. PFD Station 17 services Hayden Island and North Portland areas. Sean will be present for Fourth of July weekend with the Coast Guard.

Sean gave an update about the standpipe thing: Sean is following up with marinas who haven't had a recent hydrostatic test done by a private company within the last year. He gave a reminder that even though the hydrostatic test has a 5 year max, there are required inspections and maintenance that are annual and need to be submitted. When it comes to remodeling at a marina and electrical and electrical connection work is done, permits need to be pulled.

# Department of State Lands (DSL)-Josh Mulhollem

DSL is seeking comments on proposed changes to administrative rules (OAR 141-082 Division 82 regarding Waterway Leases) to achieve sustainable operations in managing waterway authorizations for marinas, ports, docks, floating homes, and more, as well

as implement best management practices to protect the health and safety of Oregon-owned waterways. The comment period is open from July 1 - August 15, 2025 (closes at 5 p.m. Pacific). Link:

What's proposed: Use a single method for calculating compensation for waterway leases. Currently, people and businesses leasing waterways can choose from three different methods. This creates inconsistency, administrative inefficiencies, undervalues land, and can result in inequities for users on the same waterway.

Increase application fees and introduce new fees for late renewals and legal consultation. Existing application fees do not cover the full administrative costs of processing. Adding new fees helps recover costs associated with delays and legal review when required. Require financial assurances, reduce lease terms, and update application requirements. Oregon's waterways have experienced serious environmental harms and financial risk due to some private uses of public lands. Greater protections are needed to mitigate those risks. Add clarity and minor updates. It's been over 11 years since the last update to these rules.

DSL is receiving a grant for marine debris and vessel removal.

# **OSMB-Phil Hudspeth**

Legislature session has wrapped up and three bills were passed related to OSMB: Outfitter guide bill, aquatic invasive species and OSMB budget. A few abandoned derelict vessels were removed from the waterway with help from other agencies. 2 boats were removed from the Ross Island area, 4 were removed from Astoria/Warrenton area and 1 was removed from Columbia County. OSMB put together a Rules Advisory Committee for the new waterway in Lincoln

County. Two buoys with flashing light signs were installed at each end of the Holgate Channel at the end of May. It cost OSMB \$19,000 for the buoys. OSMB has a limited budget for signage. A petition is required to create new "No Wake Zone" signage: www.boat.oregon.gov

The Aquatic Invasive Species Bill provides funding for statewide inspection stations to keep invasive mussels out of Oregon.

# **RCAC-Kelly Holtz**

RCAC has met the prior week. They have made a lot of changes to Title 28. RCAC has decided to put a brochure together regarding when to get a permit and what to get a permit for.

Ron asked Dave to comment on if a permit was needed from stringer replacement. Dave responded that if you are replacing like-kind stringers, a permit is not required; If you are making changes where the stringers are called upon to carry larger or different loads, a permit is required.

# Department of State Lands (DSL) Lease/Rates RAC

(DSL Lease RAC WOOO Representative Jim Ryan RAC Member Justin Teutsch of Columbia Crossings not present this month)

In April 2024, DSL approved the making of submerged land leases and adjacent regulations. There are three types of leases that have been consolidated into 1 fixed rate lease. The fixed rate lease can run up to 15 years if you are in good standing with the DSL. It rises 3% each year with a 15% rise at renewal of lease. There is a \$150,000 cap every 7 years and a \$175,000 cap after 7 years. Jim is asking for members to review his letter of proposed changes to the leases prior to submitting it. Public written and online comment period is 7/1-8/15, with 6 hearings scheduled, (2 virtual), Bend, Portland, Tillamook, Florence 7/21 (virtual), 22-23 coast, (virtual) Bend week of 28th.

The rent control cap for floating home marinas owned by landlords: The legislature passed a 6% cap for floating home marinas owned by landlords with 30+ spaces. For less than 30 spaces, the cap is 7%.
